<p>The ASC performed a non-covered sterilization procedure.</p>	<p>Sterilization is covered only if:</p> <ol style="list-style-type: none"> <li>(1) The individual is at least 21 years old at the time consent is obtained;</li> <li>(2) The individual has not been declared mentally incompetent by a federal, state or local court of competent jurisdiction to consent to sterilization;</li> <li>(3) The individual has voluntarily given consent in accordance with all the requirements prescribed in DHS 107.06(3)(a)4 and DHS 107.06(3)(d); and</li> <li>(4) At least 30 days, but not more than 180 days, have passed between the date of informed consent and the date of the sterilization, except in the case of premature delivery or emergency abdominal surgery. An individual may be sterilized at the time of premature delivery or emergency abdominal surgery if at least 72 hours have passed since he or she gave informed consent for the sterilization. <p>The procedure(s) provided are not medically necessary/appropriate for the condition of the recipient.</p>	<p>A medically necessary procedure means it is required to treat a recipient's illness, injury or disability and meets the following standards:</p> <ol style="list-style-type: none"> <li>1. Is consistent with the recipient's symptoms or with prevention, diagnosis or treatment of the recipient's illness, injury or disability.</li> <li>2. Is provided consistent with the standards of acceptable quality of care applicable to the type of service, the type of provider and the setting in which the service is provided.</li> <li>3. Is appropriate with regard to generally accepted standards of medical practice.</li> <li>4. Is not medically contraindicated with regard to the recipient's diagnoses, the recipient's symptoms or other medically necessary services being provided to the recipient.</li> <li>5. Is of proven medical value or usefulness and, not experimental in nature.</li> <li>6. Is not duplicative with respect to other services being provided to the recipient.</li> <li>7. Is not solely for the convenience of the recipient, the recipient's family or a provider.</li> <li>8. With respect to prior authorization of a service and to other prospective coverage determinations made by DHS, Is cost-effective compared to an alternative medically necessary service which is reasonably accessible to the recipient.</li> <li>9. Is the most appropriate level of service that can safely and effectively be provided to the recipient.</li> </ol> <p>Each provider is solely responsible for the completeness of the documentation necessary to support each claim. Claims where the provider fails to maintain records for purpose of substantiating appropriateness and necessity of services which are the subject of claims may be denied. A provider will be reimbursed only for services that are appropriate and medically necessary for the condition of the member.
