### RETURN TO CERTAIN PRE-COVID-19 PHARMACY POLICIES EFFECTIVE DECEMBER 1, 2022

Beginning in March 2020, in accordance with state and federal laws, the Wisconsin Department of Health Services (DHS) temporarily revised certain pharmacy policies in response to the COVID-19 public health emergency. This included temporary changes to the following policies:

- Expedited emergency supply list
- The overuse precaution (also known as early refill, or "ER") prospective Drug Utilization Review (DUR) alert
- Three-month supply drugs
- Quantity limits

For dates of service on and after December 1, 2022, these temporary policy changes will end, and existing pharmacy coverage and policy guidelines will be reinstated. This may include the addition of coverage and policy guidelines for drugs that were introduced during the public health emergency.

#### **Continuing COVID-19-Related Treatment Exceptions**

There are current prior authorization and utilization management exceptions for drugs and COVID-19-related treatment for BadgerCare Plus, Medicaid, and SeniorCare members. These exceptions will not be changing. For more information regarding these COVID-19-related exceptions, refer to ForwardHealth Update 2022-36, titled "Prior Authorization and Utilization Management Exceptions for Drugs and COVID-19-Related Treatment."

#### **Member Notification**

Reinstating existing pharmacy policies may result in changes to supplying members' prescriptions (for example, quantity dispensed, days' supply). ForwardHealth has created a poster and flyer to inform members of this return to existing pharmacy policies. The poster and the flyer contain the same text. The poster (8 1/2 inches by 11 inches) can be printed and displayed in provider locations; the flyer (5 1/2 inches by 8 inches) can be printed and attached to member prescriptions.

Members who may have moved since 2020, gotten a new mobile phone, or started using a new email address should log in to ACCESS (<u>English site</u>, <u>Spanish site</u>) or the mobile app, <u>MyACCESS</u>, and make any changes.

### Information Regarding Managed Care Organizations

This Update applies to pharmacy services that members receive on a fee-forservice basis and through BadgerCare Plus, Medicaid SSI, and other managed care programs. For information about managed care implementation of the updated policy, contact the appropriate managed care organization (MCO). MCOs are required to provide at least the same benefits as those provided under fee-for-service arrangements.

The ForwardHealth Update is the first source of program policy and billing information for providers.

Wisconsin Medicaid, BadgerCare Plus, SeniorCare, and Wisconsin Chronic Disease Program are administered by the Division of Medicaid Services within the Wisconsin Department of Health Services (DHS). The Wisconsin AIDS Drug Assistance Program and the Wisconsin Well Woman Program are administered by the Division of Public Health within DHS.
