We acted quickly to protect member and provider information by taking down our connection to Change Healthcare. GET READY FOR ADULT LONG-TERM CARE PROVIDER ENROLLMENT

Starting September 2024, we will require providers of home and community-based services (HCBS) for adults to enroll with Wisconsin Medicaid through the ForwardHealth Portal. So, the time is right to learn about the enrollment process! We have many resources to help you.

Not sure if this applies to you? It does if you deliver HCBS under one of Wisconsin's adult long-term care (LTC) waiver programs:

- Family Care
- Family Care Partnership
- Program of All-Inclusive Care for the Elderly (PACE)
- IRIS (Include, Respect, I Self-Direct)

Attend a live training session

We will host a bunch of live trainings about the enrollment process on Zoom from September 2024 to March 2025. Our training schedule (PDF) tells you which group of training sessions best applies to you based on the services you provide. Sessions within a training group are the same. Mark your calendar today!
