Adult Long-Term Care Provider Enrollment: Overview

Beginning in September 2024, the Wisconsin Department of Health Services (DHS) will require all providers of home and communitybased services delivered under one of Wisconsin's adult long-term care (LTC) waiver programs to enroll with Wisconsin Medicaid through the <u>ForwardHealth Portal</u> (referred to as the Portal for the remainder of this Adult Long-Term Care Update). DHS requires you to be enrolled with Wisconsin Medicaid as described in Wis. Admin. Code ch. DHS <u>105</u>.

If you only provide adult LTC waiver services, you will need to use the Portal to enroll for the first time. If you are an existing Medicaid provider who also provides waiver services, you will access the Portal to add LTC waiver programs and services to your current Medicaid enrollment.

This Adult Long-Term Care Update is for adult longterm care waiver program providers in Family Care, Family Care Partnership, PACE, and IRIS.

Participant-hired workers (PHWs) and individual self-directed support (SDS) workers will not use the Portal to enroll with Wisconsin Medicaid. PHWs and individual SDS workers will continue to be screened and certified by managed care organizations (MCOs) and IRIS (Include, Respect, I Self-Direct) fiscal employer agents (FEAs).

This Adult Long-Term Care Update is the first of a series of Updates about enrollment.

Note: The way you currently bill and submit claims for Family Care, Family Care Partnership, Program of All-Inclusive Care for the Elderly (PACE), and IRIS services will stay the same.

Preparing for the Enrollment Process

DHS is committed to frequent communication with you to make the process easy to understand. The <u>New Provider Enrollment System for Adult</u> <u>Long-Term Care</u> page of the Portal provides a description and background, including a Q&A section, about the enrollment project. This page will be updated throughout the process with new information and links to materials developed to assist you in knowing what you need to do.

The process of enrolling adult LTC waiver program providers will begin in September 2024.

Contracting and Onboarding Requirement

If you only provide adult LTC waiver services, you must meet at least one of the following conditions after enrolling with Wisconsin Medicaid through the Portal in order to:

- Be contracted with one or more MCOs to provide services for Family Care, Family Care Partnership, or PACE members.
- Be selected by at least one IRIS participant and onboarded with one or more IRIS FEAs to provide services.

If you are already enrolled with Wisconsin Medicaid and also want to provide adult LTC waiver program services, then you must add those waiver services to your Medicaid provider file. You will continue to be Medicaid enrolled through ForwardHealth and contract for waiver services with MCOs and/or onboard with FEAs.

After initial enrollment as a provider, you will be responsible for maintaining and updating your enrollment file.

Enrollment Policy Information

This is the first in a series of Updates being published between now and August 2024 providing critical information to help you prepare for Medicaid enrollment through the Portal. Updates will include key topics related to the enrollment process and will be sent to those who have signed up for email communications. Updates will also be linked on the New Provider Enrollment System for Adult Long-Term Care page of the Portal. Topics covered in this series will include:

- Risk level, federal and state database checks, and licensure and certification checks
- Reporting identifying information, provider counts, and member counts
- Change in ownership and demographic maintenance
- Effective date of enrollment, criminal background checks, and revalidation

- Obtaining support for Portal tasks
- Termination policies
- Revalidation and re-enrollment

After DHS publishes an Update, the Online Handbook will be revised as appropriate and indicate when the policy information is effective.

Information regarding the provider enrollment process will be stored in the Family Care, Family Care Partnership, PACE, and IRIS program areas of the Online Handbook. Provider enrollmentrelated policy will be available starting in September 2024 when Medicaid enrollment through the Portal becomes available for adult LTC waiver providers.

Note: Updates **introduce** new policy information. A new Update could revise policy published in a previous Update. Refer to the Online Handbook for comprehensive and up-to-date policy information.



ATTACHMENT How to Use QR Codes

TWO EASY STEPS TO ACCESS THE ONLINE PORTAL





OPEN YOUR CAMERA APP

Open your smartphone's camera app and hold it over the QR code so you see the QR code as if you were taking a picture of it. A prompt to follow a link should appear on your screen.





If it does not, you can download a QR code reader from your app store, for free, to then scan and open the QR code's hyperlink. Open the QR code reader, hold it over the QR code, and it will help you open the link.
