

2018 Best Practices/Successes

In the 2018 Annual Report, several HMOs and clinics reported successful implementation of best practices, including:

- Expanded PNCC use.
- Increased collaboration between clinics sites, and with HMOs.
- More intensive or better targeted care coordination.
- Addressing nonmedical or determinate needs.
- Expanded home visitation.
- Increased use of monitoring and metrics.

2019 PRAMS Fact Sheets

Future DHS Disparity Efforts

Medicaid Managed Care Final Rule – 42 CFR 428.340(b)(6)

- CMS requires states to analyze member demographic data, establish health disparity goals, and reduce identified disparities.
- State will focus on birth outcomes for the CY19 analysis.
- Whether these efforts will directly involve OBMH has yet to be determined.
