

Contract Amendment for BadgerCare Plus and SSI Medicaid Services

The agreement entered into for the period of September 1, 2010 through December 31, 2013 between the State of Wisconsin acting by or through the Department of Health Services, herein after referred to as the “Department” and _____, an insurer with a certificate of authority to do business in Wisconsin for the BadgerCare Plus Managed Care Program is hereby amended for the period of September 1, 2010 through December 31, 2013 as follows:

1. Replace the current table in Article V, A with the following table:

2. Replace Exhibit 6c of the BadgerCare Plus Standard Plan Contract with the Exhibit 6c attached to this Amendment.

3. Replace Exhibit 10b of the Badgercare Plus Benchmark Plan Contract with the Exhibit 10b attached to this Amendment.
4. The revised capitation rates in the exhibits of this Amendment take effect back to January 1, 2011 and continue through December 31, 2011.
5. The HMO will audit or otherwise determine if any dental provider received less than the applicable fee-for-service payment rate from the HMO or its contracted dental benefits administrator for services provided in calendar years 2010 or 2011. By October 15, HMOs must communicate to all subcontracted dental providers of the right to appeal any 2010 or 2011 dental claims that were paid below the FFS rate by the HMO or the HMO's dental benefits administrator, and provide instruction on how to appeal to the HMO and then to the Department if the provider is dissatisfied with the HMO's decision. The HMO will waive timely filing requirements for provider appeals by dental providers. By November 1, 2011 the HMO will report to the Department its progress in determining if there are any outstanding underpayments. By December 31, 2011 the HMO will assure that all necessary payment adjustments are made to correct any outstanding underpayments. The Department will accept untimely appeals from dental providers for 2010 and 2011 dates of services, and may require a corrective action plan from the HMO for dental underpayment claims that are not resolved by December 31, 2011.

All terms and conditions of the September 1, 2010 through December 31, 2013 contract and any prior amendments that are not affected by this amendment shall remain in full force and effect.
