

Prospective Drug Utilization Review Alerts

The Prospective Drug Utilization Review Alerts pharmacy data table lists the active prospective drug utilization review (DUR) alerts that may return on a real-time Point-of-Sale noncompound drug claim response and require clinical review by the pharmacy provider. If it is clinically appropriate to dispense the drug, an override by the pharmacy provider is needed to obtain reimbursement from ForwardHealth. Some prospective DUR alerts may require the pharmacy provider to obtain an override from the Drug Authorization and Policy Override (DAPO) Center. Prospective DUR also allows pre-overrides by the pharmacy provider as long as the member's supporting history (that is, drug paid claims history or the International Classification of Diseases diagnosis code on the member's pregnancy or disease profile) corresponds with the pharmacy location that is dispensing the drug.
