Introduction

Provider Electronic Solutions (PES) is Health Insurance Portability and Accountability Act of 1996 (HIPAA)compliant software used for submitting claims to ForwardHealth, which includes four pavers: Wisconsin Medicaid, Wisconsin AIDS/HIV Drug Assistance Program (ADAP), Wisconsin Chronic Disease Program (WCDP), and Wisconsin Well Woman Program (WWWP). As a payer, Wisconsin Medicaid includes BadgerCare Plus and SeniorCare. PES software cannot be used for submitting claims to Medicare or other commercial health insurance payers. Hewlett-Packard Enterprise Services (HP), the current ForwardHealth fiscal agent, supports PES software. PES is available only to BadgerCare Plus, Wisconsin Medicaid, SeniorCare, ADAP, WCDP, and WWWP providers and electronic billing services and will allow them to submit HIPAA-compliant electronic claims and adjustments to ForwardHealth. This includes the 837 Health Care Claim: Dental (837D), the 837 Health Care Claim: Professional (837P), the 837 Health Care Claim: Institutional (837I), and the National Council for Prescription Drug Programs batch standard version 1.2 (NCPDP 1.2). PES software will instruct you at the appropriate time to select Wisconsin Medicaid, ADAP, WCDP, or WWWP.

This manual is intended only to provide information specific to the electronic submission of claims. Providers should continue to refer to their BadgerCare Plus, Wisconsin Medicaid, SeniorCare, ADAP, WCDP, or WWWP publications for general information on how to bill their claims. This manual is not intended to replace, supersede, or contradict existing BadgerCare Plus, Wisconsin Medicaid, SeniorCare, ADAP, WCDP, or WWWP guidelines (i.e., benefit limitations or exclusions). All existing program guidelines, instructions, manuals, *ForwardHealth Updates*, etc., continue to apply as appropriate to all claims submitted electronically, and should be referred to on a continuing basis.

PES Registration and Installation

Registration Enrollment

Prior to submitting claims to the ForwardHealth Electronic Data Interchange (EDI) Department, you will need to complete a Trading Partner Profile form (the form can be submitted online at *www.forwardhealth.wi.gov/*) and obtain a nine-digit Trading Partner ID and unique nine-digit personal identification number (PIN). Once these numbers are obtained, you may register as an EDI user by establishing an account on the ForwardHealth Portal at *www.forwardhealth.wi.gov/*. Complete this step before setting up your options.

Note: When creating a username and password during registration enrollment, choose a username that is eight characters in length, and a password that is between eight and 20 characters in length. The password must contain at least one alpha and one numeric character; it may also include the following special characters: @ # \$ % ^. The Web login and password are case sensitive. Enter both in the Batch tab exactly as they were entered when registering.

Installation Types

Provider Electronic Solutions (PES) software may be installed on a computer's hard disk drive or on a network. When you begin the installation, you will need to choose a network or individual personal computer (PC) installation.


Downloading PES

PES can be downloaded from the Portal.

Complete the following steps. If you experience problems, contact the EDI Department. The EDI Helpdesk telephone number is 866-416-4979.

- 1. Access the Portal at www.forwardhealth.wi.gov/.
- 2. Click on the Trading Partners button.
- 3. Click the Provider Electronic Solutions link. This page contains the PES downloads.
- 4. Click the link for the WI_v0306_setup.zip file. This will begin the software download.

Type of Installation



Individual PC Installation

Once PES has been downloaded, follow these steps to install the software on your computer:

- 1. Double-click the WI_v0306_setup.exe icon.
- 2. The welcome screen displays. Click Next.
- 3. Select type of setup you need. "Typical" is for an individual PC setup. Click **Next**.
- 4. Click **Next** to accept the default destination for the software.
- 5. Click **Next** to accept the default destination for the database.
- 6. Click **OK**. A status bar displays showing the progress of the installation. You can cancel installation at any time by clicking **Cancel**.
- 7. When installation is complete, click **Finish** to exit installation.

Network Installation

To install the application for use by several users, you will need to perform a network installation. For network installation, the database can reside on the server and the application can be loaded onto individual PCs. The user may install PES on as many PCs as needed using the same Trading Partner ID.

The following instructions will install the shared database on a network and the application on the PC on which you are installing:

- Follow the Individual PC Installation instructions until step 3. When asked what type of installation you desire (step 3 of Individual PC Installation instructions), select "Typical" on the first PC. This computer will be the "primary computer" and will need to be upgraded first when there are new PES updates.
- 2. Select a target folder on the PC's C: drive or accept the default directory for the PES application.
- 3. Select a target folder (i.e., a shared network folder or another disk) for the PES database. If you want the PES database to reside in the C:\wihipaa directory, click **Next**.

- When installing PES on PCs other than the primary computer, select "Workstation" setup instead of "Typical."
- 5. Enter the location where the database was installed when installing PES on other PCs (be it on your network, disk, or default directory). Note that the Workstation computer(s) must be updated after the Typical (primary computer) is updated, each time an upgrade is released.

Installation Notes

If you install PES as a stand-alone PC application on more than one PC, you will not be able to share data between the PCs.

When applying a PES upgrade in a network environment, make sure that you upgrade all PCs running PES (primary or "typical" first, then workstations), in addition to upgrading the database (this only has to be done once per upgrade). This will ensure that all copies of PES remain synchronized.

If a re-install is required, the PES database will be overwritten. You can backup your PES database by simply making a copy of the WINEWECS.MDB file and pasting it into a safe folder or directory.

Getting Started

Opening PES

To access the Provider Electronic Solutions (PES) application after installation, use one of two methods:

- Open the application folder named WI HP Provider Electronic Solutions from the desktop, then doubleclick HP Provider Electronic Solutions.
- Click the **Start** button, select **Program**, select WI HP Provider Electronic Solutions and then WI HP Provider Electronic Solutions.

Initial Logon

The PES software provides basic security for the user through the logon process.

In the Password field in the Logon window, enter the password: "hp-pes." Click **OK**. The next field displayed alerts you that the password has expired.

Click **OK** to continue and follow the instructions for changing the password.

Note: Do not attempt to change the User ID.

Password Rules

Use the following guidelines when choosing passwords:

- Passwords are not case sensitive.
- A password may be any combination of alphabetic, numeric, and special characters.
- A password must be at least five characters in length but no more than 10 characters.

Setting Your Password

- 1. At the Login window, in the Old Password field, type "hp-pes."
- 2. In the New Password field, enter a new password.
- 3. In the Rekey New Password field, re-enter the new password.
- 4. Select a question from the drop-down list.
- 5. Enter an answer to the question in step 4.
- 6. Rekey the answer to the question in step 4.
- 7. Click OK.
- 8. The next message displayed tells you that you have successfully updated your password. Click **OK** to continue.

The system will prompt you to set up your personal options. Click **OK**. For more on options, proceed to Setting Up Options.

Setting Up Options

To submit claims and receive information, Options must be set up on each personal computer (PC) the first time you use the software. There are three options that must be confirmed or created. They are Batch, Web, and Retention. The Options window displays with the Batch tab on top.

To access Options after the initial setup, select **Tools** from the menu bar and then **Options**.

Batch Tab

This tab is used to set up communication protocols with the EDI Department.

- 1. Select the Batch tab.
- 2. Select the Trading Partner ID from the drop-down list. To add items to the drop-down list, double-click the Trading Partner ID field to access the list. The Trading Partner ID can be found on your Trading Partner Profile, which was mailed or emailed back to you upon completion.
- Enter the Web logon ID (called a username on the registration site) and Web password you created at *www.forwardhealth.wi.gov/.* The username must be eight characters in length, and the password must be between eight and 20 characters in length and may include the following special characters: @ # \$ % ^. Refer to the PES Registration and Installation chapter of this manual for more information.

Note: When PES is installed on a network, all users on the network use the same Web login ID and Web password.

- 4. Select the correct Entity Type Qualifier. Choose "Person" (individual provider) or "Non-P" (billing service, group, or facility).
- 5. Enter the last name of the individual provider or the organization name if a billing service, facility, or group in the Last/Org Name field.
- In the First Name field, enter the first name of the individual if the Entity Type Qualifier is set to "Person."
- 7. Enter the middle initial of the individual provider in the MI field, if applicable.

TIP

Be sure to enter the Web logon and Web password associated with the ForwardHealth trading partner ID you will be using on your PES transactions.

Prior to submitting transactions through PES, you must also make sure your trading partner account is entered as the "Default Provider ID" on the Switch Organization page of the secure Trading Partner account on the ForwardHealth Portal.


- 8. Enter the telephone number of the person who will be submitting the transaction in the Submitter Contact Information field.
- 9. Enter the name of the person who will be submitting the transaction in the Submitter Contact Information field.

Web Tab

This tab will allow you to submit claims to the EDI Department using an existing Internet connection.

Testing packets are available on the ForwardHealth Portal at *www.forwardhealth.wi.gov/*. The testing packets contain requirements for testing connectivity after you successfully complete the Trading Profile forms.

Options — Web Tab



Submitting claims using an existing Internet connection

Use this option if you have an existing Internet connection using any of the following connection types: cable modem, DSL modem, ISDN modem, local area network (LAN) connection, or analog modem. In most cases, the analog modem is the dial-up network for your Internet Service Provider (ISP).

- 1. Verify that the Use Microsoft Internet Explorer Preconfig Settings check box is checked. Checking this box indicates that the PES application will use the same settings as the Microsoft browser to connect to the Internet. The box is selected by default.
- 2. Select the appropriate environment indicator. The Environment Ind field defaults to "P" for production environment. Select "T" if this claim is used to test for software connectivity.

If you need to connect to the Internet using a proxy setting for the PES application, use the following steps:

- 1. Uncheck the Use Microsoft Internet Explorer Pre-config Settings check box.
- 2. Select the appropriate connection type. The Connection Type indicates whether the Internet connection is established through a LAN or a modem.
- Check the Use Proxy Server check box when a proxy server is used to connect to the Internet. The proxy server is commonly used with a LAN connection. If checked, the Proxy Information fields, including Address, Hypertext Transfer Protocol (HTTP) Port, secure Hypertext Transfer Protocol (HTTPS) Port, and Proxy Bypass will be available for entry.
- 4. Enter a proxy address if you selected Use Proxy Server. This is the IP address or Universal Resource Locator (URL) address of the proxy server used to connect to the Internet. This is a required field if you checked the Use Proxy Server check box.
- 5. Enter your HTTP port if you selected Use Proxy Server. This is the port number that the proxy server uses for standard HTTP communication. This is a required field if you checked the Use Proxy Server check box.
- 6. Enter the HTTPS port if you selected Use Proxy Server. This is the port number that the proxy server uses for HTTPS communication. This is a required field if you checked the Use Proxy Server check box.
- 7. Enter a proxy bypass, if desired, if you selected Use Proxy Server. This is the URL address that does not use the proxy server.

Retention Tab

The retention settings allow you to retain data for a specific number of days or transactions before the information is deleted from the software or before notification is given for transactions that can be archived.

 Confirm the following default settings or change the settings to meet your business needs. Use the scrolldown feature to select the appropriate setting, or enter the value that you have determined meets your business needs.

Archive Days: The default number of days is 30; the maximum number of days is 999 before the system notifies the user that it is time to archive submitted claims. If you submit large volumes of claims, it is recommended that you archive your claims at least every 30-60 days.

Max Batch: The default maximum number of batches is 10. This is the maximum number of batches retained in the resubmission option of the communication menu. Batches on the batch list will be deleted on a first-in/first-out basis. The maximum number of batches that can be retained is 999.

Max Verify: The default number of download files (835 and 997) is 25. Downloaded files will be deleted on a first-in/first-out basis. The maximum number of downloaded responses that can be retained is 999. Refer to the Communication chapter of this manual for more information on batch responses.

Max Log: The default number of communication log backups is 10. The maximum number of communication log backup files that can be retained is 999. Refer to the Communication chapter for more information on communication logs.

Max Submit Reports: The default number of submission reports is 30. The maximum number of submission reports that can be retained is 999.

Password Expiration: The default number of days before a password expires in PES is 30. The maximum number of days before a password expires is 99.

2. After completing or viewing the retention settings, select **OK** to save the settings.

Basic Skills

The keyboard shortcuts, menus, toolbars, and buttons used in Provider Electronic Solutions (PES) software are similar to other Microsoft Windows[®] software. We recommend that you use this chapter to familiarize yourself with some common functions in PES, which may save time when you enter claims.

Using the Keyboard

Many computer users find it easiest to use the computer keyboard to move around on a screen. The following is a list of keys that can be used with the PES software.

Click this key:	To do this:
Tab or Enter	Go to the next field
Shift + Tab	Go to the previous field
Left Arrow	Move backward within a field
Right Arrow	Move forward within a field
Up Arrow	Scroll up through a list
Down Arrow	Scroll down through a list
F1	Open online help when the pointer is on a data entry field
ESC	Exit the help window
Alt + Down Arrow	Show available list choices
Alt + hot keys	Hot keys are identified on the menu by an underlined letter that you hit along with the Alt key on the keyboard. These buttons vary from screen to screen.

Using the Mouse


Use the mouse the same as you would in any other software. That is, move the mouse pointer to the position on the screen where you want to work or select an option. Click the mouse button once to position your pointer at that location or to select an option. **Double-Click:** When the down arrow in a field is selected, either a window or a list selection will appear. If no data has been entered in the list, double-click the field to "jump" to it and add the required data. Refer to the Lists chapter for assistance in completing the required fields for each list.

Right-Click: Use the right mouse button for Cut, Copy, Paste, and Select All.


PES Main Window

There are two basic windows in PES. The first window has the main menu of all the functions you can choose: File, Forms, Communication, Lists, Reports, Tools, Security, Window, and Help. Some of these options are then repeated in the toolbar directly below the menu bar.

Main Menu Window



In the upper right-hand corner of the main window there is a set of three small fields you can use to hide, re-size, or close the window. You can also hide, re-size, and close the active window inside of the main window. Be careful with the X. You can close the program by clicking it. PES will always prompt you to save any changes before you close.



TIP

Use the Minimize feature to minimize PES during periods of non-use. This allows you to have access to the application throughout the day.



Another way to resize the main window is to grab the lower right-hand corner of the window with your pointer and drag it until you have the size you want.

Menu Bar

The menu bar appears at the top of the PES window. It is a list of basic commands. There are two menu bars: one for the main window, and a second that opens once you select an option.

Tool Bar

The tool bar contains shortcuts for frequently used commands that reduce the time and steps needed to activate a function. The toolbar consists of icons that represent different menu commands. To execute a command using the toolbar, simply click the button. To see a name or brief description of each button, hover the pointer over the button but do not click. The description will appear just below the button.

Find: You may use this command to locate a specific form. If you have set up a filter on the forms, you will only be able to find forms that match the filter. In other words, the find command will not search forms that do not appear in the detail window.

Filter: You may limit or filter the forms that are displayed in the detail window. This feature allows you to see only the forms you are interested in while keeping the forms you do not want to see available for future use.

Sort: You may use the sort command to control the detail window display. You may display the forms in sorted order based upon the column headings in the detail window.

Charges and Services

Total Billed Amount: The total charges to be billed to ForwardHealth.

Services: The number of service details associated with the claim.

Tabs

Information on the claim forms is organized into tabs with related fields in separate Header or Service tabs. Additional tabs also are added to some forms, such as when other insurance is indicated.

Drop-Down Lists

Click the down arrow to display a list of values. If there is a scroll bar on the right, use it to see all the options on the list. If you double-click in the field, you may be able to create or add to the list, depending on the field.

Detail

A detail lists all claims entered for the transaction.

Status Bar

The status bar indicates the state of the software, such as *Ready* or *New Record Added.* When you hover over comments, a description will be displayed in the status bar.

Active Window

You can open up to three separate forms, lists, and/or reports at one time. Select **Window** on the menu bar to display screens in a cascade, tiled, or layered view.

Command Buttons

The command buttons are located along the right side of each screen. These buttons will vary from screen to screen. See Command Buttons in this chapter for more information.

Menu Bar

This command…	Allows you to
File	In the main menu, exit from the application. While in a form, add, delete, save, undo, and print forms.
Forms	Select the online form needed. See the Claims chapters (chs. 6-11) for more information about this option.
Communication	Submit batches of forms and process batch responses, resubmit batches of forms, and view communication log files. See the Communication chapter for more information about this option.
Lists	Add and edit reference lists, which allow the user to collect information to be used when completing transactions within the software. See the Lists chapter for more information about this option.
Reports	Print summary or detail reports with information from forms or reference lists. See the Reports chapter for more information about this option.
Tools	Create and work with archives, perform database maintenance, retrieve upgrades, and change setup options. The Options selection allows the user to set up communication options and determine retention settings. See the Tools chapter for more information about this option.
Security	Prevent unauthorized use of the PES software application. See the Tools chapter for more information.
Windows	Organize windows for most Windows- compatible applications.
Help	Obtain help about PES functions, screens, menus, and fields using Contents and Index. Select About to view information about this application such as version and copyright. To reach help, you may also use F1, or double-click in a field name to get field-specific help.



Command Buttons

The user can activate command buttons by clicking them or using the hot key associated with that button. These buttons will vary from screen to screen.

New

Click this button to work with a new form. You are automatically ready to enter data into a new form when you first select a form type.

Сору

Click this button to make a copy of a previously submitted form or current form if submitting multiple claims for the same client. This action enables you to make corrections to the new form as needed.

Delete

Click this button to delete the current form. You will be asked if you are sure that you want to delete it. If you click "Yes," the form will be deleted. You will only be able to delete a form if it has a status of "R," which indicates the form is ready to be transmitted.

Undo All

Click this button to reverse all of the changes that you have made to the current form. You will only be able to undo the changes made since the last time you saved the form. You will be asked if you are sure you want to undo; if you click "Yes," all changes made since the last save will be undone.

Save

Click this button to save what you have entered in the current form or list. When you save a form, the data will be checked to see if it meets the criteria for the field (such as when a client ID number doesn't have enough digits in it or a required field has not been completed). A list of errors will be presented for you to correct. For more information on how to use the error list, see Correcting Errors in this chapter.

When you have finished working with a form, select **Save**, and, if there are no errors on the page, the form status updates in the detail to an "R" to indicate the form is ready to be transmitted.

Find

Click this button to locate specific forms in the list in the lookup window.

Print

Click this button to print data associated to the form you are currently viewing in PES. Claim forms and

Command Buttons



TIP

Hot keys are identified on the Command Buttons and on the Menu Bar by an underlined letter that needs to be clicked along with the Alt key on the keyboard. To display the hot keys on any particular screen, hit Alt. reports are displayed in a report format to be viewed online or may be printed. Lists can also be viewed or printed.

Close

Click this button or the toolbar option to close the form window. If you have made changes to the current form, you will be asked if you want to save those changes before you leave the window.

Screen-Specific Command Buttons

Three types of screens in PES have screen-specific command buttons. The screens on which these buttons are located include compound screens, other insurance screens, RX screens, service screens, and service adjustment screens.

Compound Screen Buttons

Add Ingredient

Click this button to add additional ingredients to a compound drug mixture.

Copy Ingredient

Click this button to copy the current compound drug ingredient information and make changes to it. This feature is helpful when you wish to add drug ingredients that share many of the same elements.

Delete Ingredient

Click this button to delete the compound drug ingredient.

Other Insurance Screen Buttons

Add OI

Click this button to add additional commercial insurance carriers to the claim.

Copy OI

Click this button to copy the current insurance carrier information and make changes to the data. This feature is helpful when you wish to add insurance carriers that share much of the same data as the current insurance carrier.

Delete Ol

Click this button to delete the current insurance carrier information.

Service Screen Buttons

Add Srv

Click this button to add additional services to the claim.

Copy Srv

Click this button to copy the current service screen and make changes to the data. This feature is helpful when you wish to add services that share much of the same data as the current service.

Delete Srv

Click this button to delete the current service information.

Service Adjustment Buttons

Add Srv Adj

Click this button to add other payer information, including cutbacks and payments, to the claim.

Copy Srv Adj

Click this button to copy the current service adjustment and make changes to the data. This feature is helpful when you wish to add service adjustments that share much of the same data as the current service adjustment.

Delete Srv Adj

Click this button to delete the current service adjustment information.


Correcting Errors

If all the required data is not included in a form or list, a listing of error messages will display for you to correct. Either double-click on the error message or click the **Select** button. The software will return to the field that has missing or incorrect data. You will not be able to save a form if there is missing or incorrect data.

Error Listing



Note: The software only recognizes errors such as an empty field or alpha characters in a field that should be all numbers. If you enter the wrong information, such as too many or too few units, the software will not recognize this as an error.

Exiting from Forms

Once you complete a form, you have several choices:

- **To save a form:** Choose the **Save** command button. This action will save the form in a status of "R," indicating the form is ready to be transmitted as a batch transaction. If you have more forms to be submitted, choose the **New** command button. The software will automatically save the current form to an "R" status and allow you to enter a new form.
- **To create a new form:** Select the **New** command button to add a new form or a new entry in the list options. This action automatically saves any information in the current form and indicates the form has an "R" status.
- **To copy a form:** Select the form to be copied. Select the **Copy** command button to copy a form that is in a status of archived, finalized, ready, or incomplete. This action copies the original form, allows you to make corrections to the information, and readies the form for resubmission.

Exiting from PES

There are three ways to exit from the PES software:

- Select the X in the upper right corner of the screen.
- Select File from the menu bar and click Exit.

- A = Archived
- F = Finalized
- I = Incomplete
- R = Ready

• Click the blue door icon from the toolbar.

If you have not saved your work, you will receive a prompt asking if you want to save your changes. You have three choices.

- Click **Yes** to close PES and exit.
- Click No to close the active window but stay in PES.
- Click **Cancel** to stay in the active window.

Lists

Provider Electronic Software (PES) contains lists of information that are frequently used when entering or editing data in a form. Some of the lists you will have to build; others come preloaded in the software.

Once you create a list, the information in it will be available in drop-down lists within the forms. This will speed up the data entry process when using forms and help ensure accuracy since the information is only entered once. It is strongly recommended that you build and customize your lists prior to completing claim forms.

You can also build lists during the claim submission process. When using a drop-down list in a screen, if the data you want is not there, double-click in the field to go to the appropriate list. You can then add the required data. After you save your new list entry, you will be returned to the screen in which you were working originally.

Note: It is your responsibility to update and maintain both buildable and pre-loaded lists in PES.

Lists to Build

You will have to build many of the lists you use by entering required information. These lists will take a little time to build, but once they are complete, you will use them frequently.

Depending on the type of services you render, you will need to build some or all of the following lists:

- Provider.*
- Client.*

TIP

You can copy descriptions from the lists in the List Appendix while working online. Use the Text Select Tool in Acrobat Reader, copy, and paste into the description field in PES.

Descriptions can be up to 60 characters and spaces.

- Diagnosis.
- Modifier.
- Other Payer Reject Code.
- Other Provider.*
- Policyholder.*
- Procedure/Healthcare Common Procedure Coding System (HCPCS).
- Taxonomy.
- Trading Partner.
- *Note:* We recommend that you build the lists above marked with an asterisk (*) prior to completing any claims.

Institutional providers will want to build some or all of the following additional lists:

- Revenue.
- Type of Bill.
- Condition Code.
- Value Code.

List Appendix

To help you build these code lists, you will find valid codes to choose from in the List Appendix. Valid code listings are included for all of these lists except: Diagnosis, Modifier, Procedure/HCPCS, Revenue, and Taxonomy codes.

Preloaded Lists

Some of the lists have preloaded information that you can use immediately. Take the time to look at these lists and delete any codes you know you will not be using. This will shorten the list and make it easier to use when completing forms. The preloaded lists are:

- Carrier.
- Condition Code.
- Occurrence Code.

TIP

If you are working with a long list, you can sort it according to any of the columns that are displayed. Click on the blue column title. The table will then be sorted either alphabetically or numerically by the data in that column.

- Other Insurance Reason Codes (Adjustment Reason Codes).
- Patient Status.
- Place of Service.
- Program.

Note: The Program list cannot be edited.

- Value Code.
- Visit Point of Origin.
- Visit Priority.

Working with Lists

Select the list that you would like to create or edit from the Lists option on the menu bar. You will notice the following buttons on the right side of the window:

- *New:* Click **New** to either change an existing entry in the list or to create a new entry to the list. You must then click **Save** to keep the new/altered entry.
- Delete: Click Delete to remove an entry from the list.
- Undo All: Click **Undo All** to clear all of the fields and start over.
- Save: Click **Save** to enter new data into a list.
- *Find:* Click **Find** to locate entries in lists that have data already entered.
- *Print:* Click **Print** to make a paper copy of all entries on the list.
- *Close:* Click **Close** to exit the list.

Adding Codes to a List

To add codes to any list, follow these steps:

- 1. Select the **Lists** option.
- 2. Choose the list to which you wish to add new codes.
- 3. Click New.

Deleting Codes on a List

To delete codes from a list, follow these steps:

- 1. Select the Lists option.
- 2. Choose the list from which you wish to delete codes.
- 3. Select a code in the list that does not apply.
- 4. Click Delete.
- 5. Click Yes.
- 6. Continue deleting inappropriate codes until the list contains only those codes that describe the services you provide.

Lists

Carrier List

The carrier code is a pre-loaded, three-character number that identifies an insurance carrier. This information is necessary to match all service-level adjustments to the carrier code on the header screen.

Providers may choose from any of the carrier codes listed.

TIP

Spaces, apostrophes, dashes, slashes, periods, and ampersands are allowed characters in the Carrier Name field.

Client List

The Client List requires you to enter detailed information about your clients (i.e., patients, members, policyholders). As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens. To enter a client, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Client list.
- 3. Enter data into all of the required fields on the Client screen using the following table as a guide.

TIP

In general, no special characters (such as apostrophes) may be entered in name fields. Spaces and dashes are allowed.

When entering names, verify the spelling with Wisconsin's Enrollment Verification System (EVS) and enter the same spelling in PES.

Condition Code List

The Condition Code list is preloaded and allows you to select or modify the list of condition codes used in the institutional claim forms. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the institutional claim form screens. To enter or edit condition codes, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Condition Code list.

3. Enter data into all of the required fields on the Condition Code screen using the following table as a guide.

Diagnosis List

The Diagnosis list allows you to create a list of diagnosis codes to use in the claim forms. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens. To enter a diagnosis code, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Diagnosis list.
- 3. Enter data into all of the required fields on the Diagnosis screen using the table below as a guide.

TIP

When entering diagnosis codes, do not use decimals.

TIP

The appropriate ICD code version should be used based on date of service (DOS), date of discharge, or filled date.

TIP

When entering diagnosis codes, for ease of use, identify the ICD code version in the description.

Modifier List

The Modifier list allows you to create a list of modifier codes for use on claim forms. As with other lists, once the code is entered into the list, it may be accessed from dropdown fields within the claim form screens. To enter a modifier, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Modifier list.

TIP

Refer to your service-specific *ForwardHealth Updates* and the Online Handbook for applicable modifiers.

3. Enter data into all of the required fields on the Modifier screen using the table below as a guide.

Occurrence List

The Occurrence list is preloaded and allows you to select or modify the list of occurrence codes and occurrence span codes used in the institutional claim forms. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the institutional claim form screens. To enter or edit occurrence codes and occurrence span codes, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Occurrence list.
- 3. Enter data into all of the required fields on the Occurrence screen using the table below as a guide.

Occurrence Code	Enter the two-digit occurrence code from the Uniform Billing (UB-04) Manual or refer to the Lists Appendix for valid codes.

Other Insurance Reason Code List

The Other Insurance Reason Code list is preloaded with a short list of Health Insurance Portability and Accountability Act of 1996 (HIPAA)-approved adjustment reason codes that are used by ForwardHealth to process claims. This list allows you to enter or modify a list of adjustment reason codes used in claim forms by insurance companies and Medicare. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens. To enter other insurance reason codes, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Other Insurance Reason list.
- 3. Enter data into all of the required fields on the screen using the following table as a guide.

Other Insurance Reason Code List	
Field	Description
Other Insurance Reason Code	Enter the one- to three-digit American National Standards Institute (ANSI) code identifying the reason for the adjustment. Refer to the adjustment reason codes in the Lists Appendix for valid codes that are used by ForwardHealth to process claims.

4. Click **Save** to save the data or **New** to add a new insurance reason code.

Other Payer Reject Code

The Other Payer Reject Code list allows you to enter frequently used reject codes from the National Council for Prescription Drug Programs (NCPDP) External Code List (ECL), dated September 2010. As with other lists, once entered into the list, the code may be accessed from dropdown fields within the pharmacy claim form.

- 1. Select the Lists option on the menu bar.
- 2. Select the Other Payer Reject Code list.
- 3. Enter data into all of the required fields on the screen using the following table as a guide.

Other Payer Reject Code	Enter the two- to three-digit alphanumeric code indicating the reason for the claim rejection from the other insurance or Medicare.
Description	Enter the reject code description. The description can be up to 60 characters and spaces.

4. Click **Save** to save the data or **New** to add a new other payer reject code.

Other Provider List

The Other Provider list allows you to enter information about additional providers such as referring, attending, or operating physicians. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens. Other providers can be either individual providers or organizations. To enter other providers, follow these steps:

- Select the Lists option on the menu bar. 1.
- 2. Select the Other Provider list.
- 3. Enter data into all of the required fields on the Other Provider screen using the table below as a guide.

TIP

In the Provider ZIP field on the Other Provider List screen, a ZIP code is required. If a ZIP+4 code is known for the provider, please enter this code; it will help identify the provider's practice location.

TIP

In general, no special characters (such as apostrophes) may be entered in name fields. Spaces and dashes are allowed.

Names must be submitted the same way they appear in ForwardHealth files.

Provider ID	Enter the National Provider Identifier (NPI) (for health care providers) or provider number (for non-healthcare providers) of the billing/rendering provider.
Provider ID Code Qualifier	Select the type of provider identification number used in the Provider ID field.
Taxonomy Code	Enter the taxonomy code that corresponds to the NPI entered. This field should be left blank for providers who do not use an NPI.
Entity Type Qualifier	Select "Person" for an individual provider or "Non-P" for a group or institution.
Last/Org Name	Enter the last name of the provider if the entity qualifier is "Person" or the organization name if the entity qualifier is "Non-P."
First Name	Enter the first name if the provider is an individual. This field is not required if the entity qualifier is "Non-P."
Provider Address Line 1	Enter the provider's street or mailing address. This field is required.
Provider Address Line 2	This field is optional.
Provider Address City	Enter the name of the provider's city. This field is required.
Provider Address State	Select the two-digit state code designation. This field is required.
Provider ZIP	Enter the provider's ZIP code. This field is required.

4. Click Save to save the data or New to add a provider.

Patient Status List

The Patient Status list is preloaded and allows you to select or modify the list of patient status codes used in the institutional claim forms. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the institutional claim form screens. To enter or edit patient status, follow these steps:

- Select the Lists option on the menu bar. 1.
- 2. Select the Patient Status list.

TIP

Providers who have one NPI with multiple taxonomy codes or multiple ZIP+4 codes may make duplicate Provider and Other Provider lists.

3. Enter data into all of the required fields on the Patient Status screen using the following table as a guide.

Patient Status	Enter the two-digit code from the Uniform Billing (UB-04) Manual indicating the patient's status as of the statement "covers through" date. Refer to the Lists Appendix for valid codes.
Description	Enter the patient status description. The description can be up to 60 characters and spaces.

4. Click **Save** to save the data or **New** to add a new patient status.

Place of Service List

The POS list allows you to create a list of POS codes used in the claim forms. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens. To enter a POS code, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Place of Service list.
- 3. Enter data into all of the required fields on the Place of Service screen using the following table as a guide.

TIP

Refer to your service-specific *ForwardHealth Updates* and the Online Handbook for applicable POS codes.

TIP

The NCPDP Pharmacy Claim form has a drop-down list with applicable POS codes for compound and noncompound claims.

4. Click **Save** to save the data or **New** to add a new POS code.

Policyholder List

The Policyholder list allows you to enter a list of information for the policyholder of commercial insurance carrier and Medicare policies. As with the Provider and Client lists, this list should be entered before completing a claim when the client has a commercial insurance carrier or Medicare. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens.

TIP

The most common Insurance Type Codes used in the policyholder list are:

C1: Commercial Insurance

HM: Health Maintenance Organization

- MB: Medicare Part B
- MP: Medicare Primary

To enter policyholder information, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Policyholder list.
- 3. Enter data into all of the required fields on the Policyholder screen using the table below as a guide.

Procedure/HCPCS List

The Procedure/HCPCS list allows you to create a list of procedure codes used most often when billing on 837 Health Care Claim: Institutional Inpatient, Institutional Outpatient, Professional, and Dental claim forms. As with other lists, once the code is entered into the list, it may be accessed from drop-down fields within the claim form screens.

TIP

The appropriate ICD code version should be used based on DOS, date of discharge, or filled date.

To enter procedure codes, follow these steps:

- 1. Select the Lists option on the menu bar.
- 2. Select the Procedure/HCPCS list.
- 3. Enter data into all of the required fields on the Procedure/HCPCS screen using the table below.

TIP

When entering diagnosis codes, for ease of use, identify the ICD code version in the description.

ForwardHealth forms are available via the ForwardHealth Portal, *www.forwardhealth.wi.gov/.* If ForwardHealth does not receive the attachment within the 30-day deadline, the claim will be processed without the attachment and may be denied.

In general, no special characters (such as apostrophes) may be entered in name fields. Spaces are allowed.

Correcting Errors on Dental Claims

If all of the required information is not included in a form, a list of error messages will display that will need to be corrected before the form can be submitted. To correct an error, do one of the following:

- Double-click on the error message.
- Click on the error message and click Select.

PES will return to the field that has missing or incorrect data.

Submitting New Dental Claims

Once you have completed the form and have saved the information, you are ready to submit the claim to the Electronic Data Interchange (EDI) Department.

- 5. Click on the appropriate form type(s) under Files to Send.
- 6. Click Submit.

TIP

To prevent submission of a specific claim(s) within a batch, save the claim(s) as incomplete ("I" status) by inserting a tick mark (" \sim ") in any of the form's fields and pressing Save.

TIP

You may only submit claims that have a status of "R." All claims in "R" status will be submitted when you perform a batch submission.

TIP

Denied claims may be copied, corrected, and submitted as new claims.

Resubmitting Dental Claims

Use this feature when, although you have previously submitted a claim or batch of claims, Wisconsin Medicaid or WCDP requests that you resubmit the claim(s).

Resubmitting a Single Claim

- 7. Select "Medicaid" or "WCDP" from the Program field.
- 8. Click on the appropriate form type under Files to Send.

- 10. PES will post messages in the Transmission window updating you on the progress of the transmission.

Resubmitting or Copying a Partial or Entire Batch

To resubmit a partial or entire batch of claims, click the dental button on your toolbar and follow these steps:

- 2. Click Resubmission.
- 3. Select the appropriate batch from the list of batches displayed by:
 - Clicking **Copy** to copy the entire batch.

Adjusting Paid Status Dental Claims

PES allows you to resubmit a claim(s) to Wisconsin Medicaid or WCDP even after the claim shows a status of "paid." To resubmit a paid claim, click the dental button on your toolbar and follow these steps:

- 1. Select the claim you want to resubmit at the bottom of the Header 1 tab.
- 2. Click Copy.
- 3. Select "7" in the Claim Frequency field.
- 4. Enter the 13-digit internal control number (ICN) in the Original Claim # field. Refer to your Remittance Advice for the ICN, or look for the payer claim control number on your 835 transaction.
- 5. Make adjustments to the incorrect portions of the claim as needed.

Note: In addition to the adjusted information, all correct details of the original claim must be included, as all details and amounts will be resubmitted in your adjustment.

- 6. Click Save.
- 7. Click Communication on the menu bar.
- 8. Click Submission.

Providers may submit paper attachments to electronic claims submitted through PES. Enter an Attachment Control Number (ACN) in the Header 1 screen and mail the paper attachment to ForwardHealth within 30 calendar days of claim submission. You must include the Claim Form Attachment Cover Page, F-13470, with the paper attachment and indicate the same ACN on the form. ForwardHealth forms are available via the ForwardHealth Portal, *www.forwardhealth.wi.gov/.* If ForwardHealth does not receive the attachment within the 30-day deadline, the claim will be processed without the attachment and may be denied.

Nursing Home Claims

For dual entitlees, outpatient charges such as therapies, durable medical equipment, and Xrays are billed to Medicare Part B. Bill these crossover claims using the Institutional Outpatient claim form in Provider Electronic Solutions (PES). If this is a straight Medicaid claim, however, use the Professional claim form.

Room and board charges are billed to Medicare Part A. Bill these crossover claims using the Institutional Nursing Home claim form.

If you are billing for Medicare Part A coinsurance days, the crossover claim must only show the days covered by Medicare. If those days fall in the middle of the month, bill as follows:

- First part Straight Medicaid claim.
- Second part Medicare crossover claim.
- Third part Straight Medicaid claim for the remainder.

TIP

In general, no special characters (such as apostrophes) may be entered in name fields. Spaces are allowed.

When entering names, verify the spelling with Wisconsin's Enrollment Verification System and enter the same spelling in PES.

Correcting Errors on Institutional Nursing Home Claims

If all of the required information is not included in a form, a list of error messages will display that will need to be corrected before the form can be submitted. To correct an error, do one of the following:

- Double-click on the error message.
- Click on the error message and click **Select**.

PES will return to the field that has missing or incorrect data.

Edit All Feature for Institutional Nursing Home Claims

PES offers an Edit All feature for creating nursing home claims. Each claim to be edited must be in an "R" (ready to transmit) status. To use the Edit All feature, follow these steps:

- 1. Choose one of the following two methods of copying your claims:
 - Select a previously submitted claim in an "F" (finalized) status from the list of previously finalized claims. Click **Copy**. Click **Save**.
 - Select a batch of previously submitted claims, copy the entire batch, and save them as new claims. Refer to the instructions for copying batch forms in the Communication chapter.
- 2. Click Edit All.
- 3. Enter the DOS in the From and To DOS fields.
- 4. Enter the number of days associated with the date span.
- 5. Click **OK**. A message displays verifying the number of claim forms to be submitted. If correct, click **Yes**.
- 6. Review each form to verify that the billed amount and client liability are correct for the number of days billed on the claim.
- 7. Click Close.

TIP

Perform the "Edit All" feature first, then add any new claims to the batch. If you choose to edit the entire batch instead of single claims, be sure to verify that you provided each of the services submitted. 8. Follow the instructions for submission in Submitting New Institutional Nursing Home Claims in this chapter.

Submitting New Institutional Nursing Home Claims

Once you have completed all required screens for your claim and have saved the information, you are ready to submit the claim to the Electronic Data Interchange Department.

All forms are submitted by batch. To submit new claims, follow these steps:

- 1. Click **Communication** on the menu bar.
- 2. Click **Submission**. The Batch Submission window will display.
- 3. Select "Web Server" from the Method field.
- 4. Select "Medicaid" from the Program field.
- 5. Click on the appropriate form type(s) under Files to Send.
- 6. Click Submit.
- 7. PES will post messages in the Transmission window updating you on the progress of the transmission.

Resubmitting Institutional Nursing Home Claims

Use this feature when, although you have previously submitted a claim or batch of claims, Wisconsin Medicaid requests that you resubmit the claim(s).

TIP

To prevent submission of a specific claim(s) within a batch, save the claim(s) as incomplete ("I" status) by inserting a tick mark (" \sim ") in any of the form's fields and pressing Save.

TIP

Denied claims may be copied, corrected, and submitted as new claims.

TIP

You may only submit claims that have a status of "R." All claims in "R" status will be submitted when you perform a batch submission.

TIP

Do not click on Files to Retrieve when you are submitting a claim. Refer to the Communications chapter of this manual for more information on retrieving batch responses.

- 5. Make adjustments to the incorrect portions of the claim as needed.

Note: In addition to the adjusted information, all correct details of the original claim must be included, as all details and amounts will be resubmitted in your adjustment.

Reason Codes/Amts	Select the code identifying the reason for the adjustment — the difference between the billed and paid amounts — made by the other insurance or Medicare (if applicable). Enter the amount indicated by other insurance for each reason code. This field is only required if an insurance carrier made an adjustment. Refer to Appendix 1 of this manual for a code list and descriptions.

Up to 25 National Drug Codes (NDCs) may be entered for each drug-related HCPCS J-code.

Correcting Errors on Institutional Outpatient Claims

If all of the required information is not included in a form, a list of error messages will display that will need to be corrected before the form can be submitted. To correct an error, do one of the following:

- Double-click on the error message.
- Click on the error message and click Select.

PES will return to the field that has missing or incorrect data.

Edit All Feature for Institutional Outpatient Claims

PES offers an Edit All feature for creating home health claims. Only home health providers (those using type of bill "33") may use this feature. Each claim to be edited must be in an "R" (ready to transmit) status. To use the Edit All feature, follow these steps:

- 1. Choose one of the following two methods of copying your claims:
 - Select a previously submitted claim in an "F" (finalized) status from the list of previously finalized claims. Click Copy. Click Save.
 - Select a batch of previously submitted claims, copy the entire batch, and save them as new claims. Refer to the instructions for copying batch forms in the Communication chapter of this manual.
- 2. Click Edit All.
- 3. Enter DOS in the From and To DOS fields.

TIP

Only providers of end-stage renal disease services are required to report NDC information.

TIP

Perform the "Edit All" feature first, then add any new claims to the batch. If you choose to edit the entire batch instead of single claims, be sure to verify that you provided each of the services submitted.

- 6. Review each form to verify that the billed amount is correct for the number of days billed on the claim.

Other Insurance and Medicare

This chapter will provide you with supplemental information about submitting claims when a client has other insurance, Medicare, or both. These instructions only apply to the 837 Health Care Claim: Dental (837D), the 837 Health Care Claim: Professional (837P), and the 837 Health Care Claim: Institutional (837I). For step-by-step instructions on completing forms, refer to the individual claim chapters.

Other Insurance

Not all providers are required to bill Other Insurance (OI), even though the policyholder may have other insurance. The following providers do not have to bill other insurance, and should not enter a "Y" in the Other Insurance Ind field:

- Specialized Medical Vehicle.
- Personal Care.
- Case Management.
- Family Planning Clinics.

Reporting Other Insurance Payments

You will use the OI Adj tab (header level) and in some cases the Srv Adj tab (detail level) to report other insurance payment information in Provider Electronic Solutions (PES).


Look at the Remittance Advice (RA) that was sent to you by other insurance. For payment information that was reported at the header level, complete the OI Adj tab in PES. For payment information that was reported at the service level, complete the Srv Adj tab.

The instructions in this section apply to all 837 claim types. The screens for Institutional Nursing Home are shown just as examples. When completing the screens for other insurance, keep in mind the following:

- The appropriate policyholder carrier code should be selected.
- On the OI tab, pick the most appropriate code for the Claim Filing Ind Code. For example, use "CI" to indicate commercial insurance, or use "HM" to indicate an HMO.
- *Note:* Do *not* use claim filing indicator code "16" to indicate an HMO. This code indicates a Medicare plan.

Example of a Payable Claim



- On the OI Adj tab, the Paid Date/Amount should be the date and dollar amount reported to you by the other insurance carrier.
- The Remaining Patient Liability is the amount owed after adjudication of the claim by the other insurance.

- Choose the appropriate adjustment group code that describes the reason that the other insurance carrier did not pay the charges in full. For example, "PR" indicates patient responsibility and should be used when reporting coinsurance or deductible amounts.
- Choose the most appropriate code (or the ANSI code given to you by the carrier on the explanation of benefits) in the reason code field. Adjustment reason codes that are used by ForwardHealth to process claims are located in Appendix 1 of this manual.
- Enter the dollar amount that correlates with the reason code.
- *Note:* The dollar amount entered in the Paid Amount field and the dollar amount entered in the Adjustment Group Codes/Reason Codes/Amounts field must equal the total amount of your claim. If you have completed the Srv tab, the total billed amount will be displayed at the top of the OI Adj tab.

Medicare

If you are billing Medicare Managed Care, refer to the section called "Medicare Managed Care" found in this chapter. For more information on Medicare denials, refer to the "Reporting Other Insurance or Medicare Denials" section in this chapter.

Note: Not all providers are required to bill Medicare, even though the policyholder may have Medicare coverage. Refer to the ForwardHealth Online Handbook for more information.

You will use the Medicare tab (header level) and in some cases the Srv Adj tab (detail level) to report Medicare payment information in PES.

Look at the RA that was sent to you by Medicare. For payment information that was reported at the header level, complete the Medicare screen in PES. For payment information that was reported at the service level, complete the Srv Adj tab. To access the Srv Adj tab, select "Y" in the Service Adjustment Ind field on the appropriate service tab.

Note: For each detail in which you wish to complete service adjustment information, you will need to highlight that service line and select "Y."

Medicare Information for Institutional Claims

Medicare pays at the header level for inpatient hospital and nursing home providers. Outpatient hospital claims may pay at the header level or the detail level, so providers should enter Medicare adjudication amounts (e.g., allowed, paid, coinsurance, copayment, and deductible amounts) in the same way they were received on the Medicare remittance information.

When Medicare pays at the detail level for outpatient hospital claims, begin by completing only the top portion of the Medicare tab.



In the example above, assume that the dollar amount billed for the detail was \$95.00, so \$50.00 (Paid Amount) + \$10.00 (PR-1) + \$35.00 (CO-96) = \$95.00 (dollar amount billed for the detail).

Medicare Managed Care

To submit a Medicare Managed Care (MMC, also known as Medicare + Choice, Medicare Cost, or Medicare Risk) claim using PES software, you will need to use the Medicare tabs. To activate and make the Medicare tabs visible, set the Medicare Ind field to "Y." This indicator may be found on the last Header Tab of any open claim form.



Once the Medicare Ind has been set to "Y," a new Medicare tab will appear. Medicare Managed Care information can be entered at the header level on this tab. When MMC information is entered at the header level, all payments and dollar amounts will be applied to every service line on the claim.

Other Insurance and Medicare Payment on the Same Claim

When reporting both other insurance and Medicare payments on the same claim, you will need to report Medicare payments first.

 Report Medicare or OI payments at either the header level or the detail level, as previously discussed in this chapter.

In this example, assume that Medicare paid \$320.00 as primary.

The Other Insurance tab will need to report the Medicare payment as Adjustment Group Code Other Adjustment (OA) and Reason Code 23 (Payment adjusted – paid by another payer). Other noncovered charges may also be reported under Adjustment Group Code OA with an appropriate Reason Code.

The Total Billed Amount is \$560.00. To balance the claim, add the Paid Amount and the Adjustment Group Codes/Reason Codes/Amounts. \$40.00 (Paid Amount) + \$40.00 (PR-2) + \$320.00 (OA-23) + \$160.00 (OA-45) = \$560.00 (Total Billed Amount).


Providers can only select two Adjustment Group Codes on the OI Adj tab. Patient responsibility amounts should always be indicated under Adjustment Group Code PR. For claims that indicate payments by both Medicare and OI, the Medicare paid amount should always be indicated under Adjustment Group Code OA.

If there are other noncovered amounts (commonly reported as Adjustment Group Code/Reason Code CO-45 or CO-96 on remittance information), indicate the noncovered amounts under Adjustment Group Code OA with the correct Reason Code (45 or 96). Amounts for coinsurance, the Medicare payment amount, and other noncovered charges.

- Choose the appropriate adjustment group code that describes the reason that the other insurance carrier did not pay the charges in full. For example, "PR"

indicates patient responsibility and should be used when reporting coinsurance or deductible amounts.

- Choose the most appropriate code (or the ANSI code given to you by the carrier on the explanation of benefits) in the reason code field. Adjustment reason codes used by ForwardHealth to process claims are located in Appendix 1 of this manual.
- Enter the dollar amount that correlates with the reason code.
- *Note:* The dollar amount entered in the Paid Amount field and the dollar amount entered in the Adjustment Group Codes/Reason Codes/Amounts field must equal the total amount of your claim. If you have completed the Srv tab, the total billed amount will be displayed at the top of the OI Adj tab.

Communication

Provider Electronic Solutions (PES) software provides several functions related to communicating with the Electronic Data Interchange (EDI) host. The most basic functions of communication, submitting and resubmitting claims, are found in the individual claim chapters in this manual. Communication functions outlined in this chapter include:

- Copying batch forms.
- Viewing batch responses.
- Viewing the communication log.

Copying Batch Forms

Use this option to copy an entire batch of forms or a portion of a batch of forms for use later. You can then edit the forms in the appropriate claim windows. After editing the forms, you may resubmit them using the resubmission procedures described in the appropriate claim form chapter. To copy an entire or partial batch of forms:

- 1. Click **Communication** on the menu bar.
- 2. Click Resubmission.
- 3. Select the appropriate batch from the list of batches displayed by clicking on the batch.
 - Click **Copy** to copy the entire batch.
 - Click **Deselect All** and select individual forms to copy from the batch. Click **Copy**.
- 4. Once you have copied the desired forms, you may modify and resubmit them.

Retrieving Batch Responses

To retrieve a 999 Functional Acknowledgement (999), 835 Health Care Claim Payment/Advice (835) transaction, or a National Council for Prescription Drug Programs (NCPDP) Pharmacy Batch Response, do the following:

1. Click **Communication** from the menu bar.

- 2. Click **Submission.** The Batch Submission window will display.
- 3. Select "Web Server."

- 4. Select "Medicaid," "WCDP," "ADAP," or "WWWP" from the Program field.
- 5. Click on the appropriate form type(s) under Files to Receive.
- 6. Click Submit.

PES will post messages in the Transmission window updating you on the progress of the transmission.

Viewing Batch Responses

To view a 999 Acknowledgement, an 835 transaction, or the NCPDP Pharmacy Batch Response(s), do the following:

- 1. Click **Communication** from the menu bar.
- 2. Click View Batch Response.
- 3. Locate the desired batch. All transactions submitted within the batch will be displayed in the batch report.

TIP

You can track your 999 Acknowledgement back to its respective 837 Health Care Claim (837) submission by matching the Group Control Number from the 999 to the Group Control Number in the communication log of the 837 submission.

Reading Pharmacy Batch Responses

The Pharmacy Batch Response includes useful information about how the pharmacy claim has processed. Pharmacy providers may use the batch response to respond to the claim right away. The sample Pharmacy Batch Responses below display the following information:

- The status of the transaction (e.g., paid or denied), internal control number for tracking purposes, and explanation of benefit code descriptions.
- The actions taken on the claim, such as the amount that the patient should pay toward the prescription, the ingredient cost or dispensing fee that ForwardHealth will pay, and deductible or copayment amounts that the patient owes.
- For all denied claims, the name(s) of the ForwardHealth program(s) in which the member was enrolled on the date of service.

Providers who have questions about a Pharmacy Batch Response should contact the EDI Helpdesk for assistance. The telephone number for the EDI Helpdesk is 866-416-4979. The Helpdesk can also be contacted using the Contact Information tab in the secure Provider area of the ForwardHealth Portal.

Viewing Communication Logs

Use the communication log to check on submission information. The log displays a list of files submitted along with the file size, creation date, and creation time. To view the communications log:

- 1. Click **Communication** on the menu bar.
- 2. Click **View Communication Log**. The Communication Log window opens and displays a list of recent submissions.
- Click on the desired file. The submission information for the selected file will be displayed in the lower portion of the screen.

Reports

Use the Reports command on the menu bar to select and print a variety of reports, including claims and lists.

Detail Form Reports

A detail report contains all the fields for a particular form. You may print a copy of the contents of any form. To view a detail report:

- 1. Click **Reports** on the menu bar.
- 2. Click Detail Forms.
- 3. Select the desired form type.
- 4. To narrow a report request, enter the batch number from the communication log file or the client's member identification number.

- 5. In the Form Status field, choose a status from the dropdown list or enter the submission date in the Submit Date field.
- 6. Click OK.
- 7. Click Print to create a hard copy of the form.
- *Note:* If no criteria are specified before clicking **OK**, all of the forms in the database for that form type will be included in the report.

Summary Reports

A summary report lists only a few of the fields from the detail form and is a good way to get an overview of a series of forms in a single report. Summary reports are available for all form types.

To create a summary report, follow the directions for Detail Form Reports, but select **Summary Reports** in step 2.

List Reports

List reports can be displayed online or printed. The report will include all of the codes available under that list and their respective descriptions. To view a list report, select the desired list from the **Reports** command on the menu bar.

Tools

The Tools menu commands discussed in this chapter include:

- Archive.
- Database Recovery.
- Get Upgrades.
- Change Password.
- Options.

The Security command on the menu bar is also discussed in this chapter.

Archive

Archiving is the process that is used to keep the size and space required by your data small enough for it to be useful to you, while maintaining a record of the forms you have entered. It is recommended that you archive your claims.


When setting up the retention option under your personal options, you can choose how many days history you want to keep online. The standard setting is 30 days; however, you may select the setting that best suits your needs.

When you create an archive, the system will copy any form you have submitted more than 30 days ago to a compressed file and then delete that form from the database. This is designed to make the management of forms easier and keep the space on the hard drive used by the application to a minimum. You may place the compressed archive file on a disk or leave it on your hard drive.

Forms that are ready to be submitted will not be archived and will remain in the online database until you submit or delete them. Forms that are incomplete and were created before the archive date will be deleted; these forms will not be saved in the archive file.

To create a form archive, follow these steps:

- 1. Click **Tools** on the menu bar.
- 2. Click Archive.



- 3. Click Create.
 - *Note:* If you are working in a network environment and other users have access to Provider Electronic Solutions (PES) through the network, you will need to ask all users to exit PES before archiving.
- 4. Click OK.
- 5. Click Yes.
- 6. Select all transaction types to be archived, or click **Select All**.

You may change the default directory, the name of the file for the archive, and the number of days used to archive forms. These changes will apply to this session only.

- 7. Click OK.
- 8. Click **OK** to exit the Archive window once the process is complete.

Restore Archive

The Restore function recalls forms from an archive file and puts them back into the online database. Forms that have been restored will have a status of "A." You will not be able to change these forms; however, you can view, print, or copy them. To restore files from an archive file:

- 1. Click **Tools** on the menu bar.
- 2. Click Archive.
- 3. Click Restore.
- 4. Click **Browse** to select the file to restore.
- 5. Select the file to be restored and click **Open**.
- 6. Click Next.
- 7. Select the type of form desired on the list of form types available. Click **Next**.
 - *Note:* If the form type selected does not have any forms archived in the file, you will receive a message to this effect. Click **OK**, and select another form type or click **Back** to change the archive file to be restored.

TIP

Although you cannot select individual claims to archive, you may archive all claims and then restore an individual claim or claims that you wish to keep within your claim form for copying or referral.

- 8. Click either **Restore All Forms** or **Restore Only Selected Forms**. If you choose to restore only selected forms, select the forms you want to restore and click **Finish**.
- 9. Click OK.

Database Recovery

The Database Recovery option is designed to help you work with the Electronic Data Interchange (EDI) Helpdesk personnel to fix problems with the database. The telephone number for the EDI Helpdesk is 866-416-4979. The Helpdesk can also be contacted using the Contact Information tab in the secure Provider area of the ForwardHealth Portal.

Compact Database

This option is used to make database files smaller and to better organize them. Each time you delete a form, empty space is created. The compact database option releases the empty space so that it may be used again.

Prior to running the compact database option, all users must be out of the database if the software is set up in a network environment.

To use compact database:

- 1. Click Tools.
- 2. Click Database Recovery.
- 3. Click Compact.

Repair Database

This option will attempt to validate all system tables and all indexes. Generally, this feature is helpful when you are having trouble accessing your data. You may use this feature any time you decide it may be helpful. It is recommended that you run the compact database utility after you use the repair database option.

Prior to running repair database, all users must be out of the database if the software is set up in a network environment. To run the repair database option:

- 1. Click Tools.
- 2. Click Database Recovery.
- 3. Click Repair.

Unlock Database

Sometimes errors will cause database locks. The database may lock after submitting forms, archiving forms, restoring forms, and sometimes when adding or editing forms. To unlock the database:

- 1. Click Tools.
- 2. Click Database Recovery.
- 3. Click Unlock.

Get Upgrades

The EDI Department will inform users when a PES upgrade is available via email. Users should check for upgrades on a weekly basis and download them when available, using the instructions below. Failure to perform upgrades will prevent users from submitting claims to Wisconsin Medicaid, Wisconsin AIDS/HIV Drug Assistance Program, Wisconsin Chronic Disease Program, or Wisconsin Well Woman Program.

To get an upgrade for PES:

- 1. Choose Tools.
- 2. Choose Get Upgrades.
- 3. Follow online instructions.

Once the upgrade is downloaded, exit the application and go into the upgrade application to apply the upgrade. If you have installed PES on several PCs, you will need to get upgrades for each PC and apply the upgrades individually.

Note: Always use the upgrade function. Do not load a new version of PES; this would result in the loss of all lists and forms that have been created.

TIP

If you are performing multiple upgrades, be sure to execute *each* upgrade to receive all software changes.

Passwords

All authorized users must have a password to access PES software. A password may be any combination of alphabetic, numeric, and special characters. It is not case sensitive. A password must be at least five, and no more than 10, characters in length.

Changing Passwords

The Change Password option allows you to change your login password at any time. PES records the date the password was changed.

PES requires you to change your password after the number of days designated in the options retention setting has elapsed. To change your password:

- 1. Click **Tools**.
- 2. Click Change Password.

- 3. Enter the old password.
- 4. Enter a new password that is five to 10 characters in length in the New Password field.
- 5. Re-enter the new password in the Rekey New Password field.
- 6. Click OK.

Security

Security Maintenance

The Security Maintenance window is only accessible by a user logged on with a valid user identification (ID) and

password with assigned administrative authority. The security maintenance function is used to:

- Assign additional user IDs.
- Reset a password for a user.
- Delete obsolete user IDs.

To enter or edit a user's information, follow these steps:

- 1. Click Security.
- 2. Click Security Maintenance.

- 3. Enter a user ID. If you select an existing user ID, the user information fields will populate with the user's data.
- 4. Enter or edit the Password field. When a password is assigned or changed through the security maintenance function, the password is automatically set as expired and the user will have to change his or her password at the first login.
- 5. Enter or edit the Authorization Level field. Users with an authorization level of "2" will not have access to the security functions in PES.
- 6. Click **Save** to save the new user information or **Add** to add an additional user.

Web Password Reset

When the Web login password has expired, PES will notify users with a message. The Web login password can be changed on the ForwardHealth Portal at *www.forwardhealth.wi.gov/.*

Forgotten Password


If you forget your login password, the Forget Password function in PES will prompt you with the question that you entered when you first keyed in your password. Once the correct answer to this question is entered, PES will allow you to reset your password.

Note: The Forgotten Password feature is only available on the primary (Typical install) computer.

If you know you have forgotten your password, follow the steps below starting with step 1.

If you enter incorrect passwords on three consecutive attempts, the Forget Password function will be invoked automatically; in this case, begin with the instructions in step 2.

1. Click Forgot Password on the Login window.



2. Enter the answer to your password reset question.

- 3. Click OK.
- 4. Enter and rekey your new password in the Password Reset window. Click **OK**.
- 5. A message will display indicating that the password update was successful.

TIP

If after three consecutive attempts you do not enter a correct answer in the Password Help window, PES will ask if you want to reset your password.

If you click **Yes**, the password will be reset for you. If you click **No**, the application will close. You will then need to call the EDI Helpdesk to request a new password. The EDI Helpdesk will need your User ID and Reset Key to set up a new password.
