

Supportive Home Care Agencies With an EVV-Only Provider Medicaid ID Revalidation Live Training Schedule

The Wisconsin Department of Health Services (DHS) has developed a training specifically for supportive home care agencies that have an electronic visit verification (EVV)-only provider Medicaid ID and deliver services (S5125, S5126, T1019, and T1020) under one of Wisconsin’s adult long-term care (LTC) waiver programs. This training will help you update your EVV-only enrollment to full Wisconsin Medicaid enrollment through the ForwardHealth Portal (the Portal). **ForwardHealth is using the term “revalidation” for this process to convert your EVV-only enrollment to full Medicaid enrollment. You will keep the same provider ID after revalidation.**

The deadline to revalidate is January 1, 2026. You must revalidate to provide services or receive payment from managed care organizations or IRIS (Include, Respect, I Self-Direct) fiscal employer agents.

All trainings are in Central Time and cover the same content. You must register to attend. Attend as many as you like! If you are unable to make one of the training sessions, a video of the training will also be available on the Trainings page of the Portal under the Electronic Visit Verification (EVV) drop-down menu at forwardhealth.wi.gov/WIPortal/cms/page/trainings/home.
