Summary of changes for 3M™ Enhanced Ambulatory Patient Grouping (EAPG) System

For licensees of the 3M[™] Enhanced Ambulatory Patient Grouping (EAPG) System, this document identifies changes for v3.17, effective January 1, 2022.

The EAPG grouper vEAPG v3.17 contains versions 3.11 through 3.17; seven years' worth of grouper versions are retained (2015 through 2021). Additionally, grouper version 3.10 remains in the grouper through 2022 for historical claims processing. However, code set updates are not included. Effective January 1, 2023, v3.10 will be removed from the component.

Each year, 3M revises the EAPG patient classification logic for two reasons:

- 1. To accommodate changes in health care code sets, most importantly the International Classification of Diseases, Version 10, Clinical Modification (ICD-10-CM), the Current Procedural Terminology (CPT®), and the Healthcare Common Procedure Coding System (HCPCS). The U.S. Department of Health and Human Services (DHHS) usually does an annual update to the ICD-10-CM code set each October 1. The American Medical Association makes its major update to the CPT code set each January 1 and makes some additional updates quarterly. DHHS updates the HCPCS code set quarterly. 3M releases quarterly updates of the EAPG grouper to reflect code set updates made during the year.
- 2. 3M continually performs research to enhance the clinical precision of the EAPG logic, that is, how patients are classified into one or more EAPGs per ambulatory care visit. These enhancements are implemented each year with the January 1 release.

As shown in Table 1, between October 1, 2020, and January 1, 2022, there is a net increase of 132 ICD-10-CM diagnosis codes, or 0.18%. Table 2 shows a net increase of 350 CPT®/HCPCS codes or 1.95%.

In addition to changes to reflect modifications in the national diagnosis and procedure code sets, 3M is making several enhancements to the clinical logic. In updating the clinical logic, changes have been made to improve the precision of the clinical logic by considering customer recommendations, shifts in coding, changes in practice, and economic cost shifts.

As coding systems are revised, and new technology and advances in medicine occur, the need for new EAPG groups, as well as code assignment changes to EAPG groups, are reviewed and evaluated each year. New EAPG groups may be added, and obsolete groups may be deleted. Modifications occur due to code assignment changes, and groups are reviewed for clinical homogeneity across current industry trends, claim reporting frequency and reimbursement. A comparison table of the EAPG changes between v3.16 and v3.17 is provided in Table 3.

Highlights of the changes made to the EAPG grouper field and logic changes are listed below. More detailed information about clinical changes made to EAPGs is provided later in this document.

EAPG grouper field and logic changes

New input fields

Removal of ICD-9-CM diagnosis code content

The ICD-9-CM diagnosis code content will be removed from the January EAPG grouper. Related documentation and fields associated with grouping, logic, and options will be updated to reflect this change. This impacts several fields:

- Input fields: Code Type Indicator*, Diagnosis code fields (*Note: the Code Type Indicator field remains in the software, but is deactivated)
- Output fields: Medical Visit diagnosis, Pointed Diagnosis code, Linked Diagnosis code
- Option related fields: Linked Diagnosis, Conditional EAPG/Dx Required and Conditional EAPG/Dx Required Range, Secondary Dx Present,

New user options

- Mid-quarter Effective Date Option: A mid-quarter effective date is an effective date that may be published by an agency such as the AMA or CMS, indicating that the effective coverage or termination of a CPT® or HCPCS code may occur with a mid-quarter date that is between quarter boundary start dates. A new option is implemented with an enable/disable switch to indicate if the user chooses to recognize mid-quarter dates. If the option is enabled and a HCPCS is reported outside of the defined mid-quarter date(s), then an error EAPG (999) is returned with Line-Item Unassigned Flag 24. By default, the option is enabled, and the internal grouper table will be pre-populated with mid-quarter dates recognized by the AMA and CMS from over the past several years.
- User Customizable HCPCS Coverage Dates List Option: An alternative option for end-users
 to create their own list of CPT or HCPCS codes with policy-defined coverage dates (effective
 and termination dates). If a HCPCS is reported outside of the defined coverage dates, an
 error EAPG (999) is returned with Line-Item Unassigned Flag 24. To use the new list option,
 the mid-quarter effective date flag option mentioned previously must be enabled to process
 user-defined dates prior to, or, in superseding, pre-defined mid-quarter dates from the
 internal grouper table.

Revised user options

User Customizable Inpatient Only Procedure List option: With the release of version 3.17, all procedures previously defined as "inpatient only" have been assigned to payable EAPG groups. The previous option "Inpatient Only Procedure Adds" will be redefined as a user customizable list upon which users may add significant procedure type (types 2, 21-25) CPT/HCPCS and/or EAPGs which the user chooses to continue to define as inpatient only. If

the list is populated with HCPCS and/or EAPGs, EAPG 993 (User-Defined Inpatient Only Procedure) continues to be returned, with Line-Item Unassigned Flag 2 (Inpatient procedure). Note that if the end-user attempts to add a HCPCS or EAPG that is not of significant type (2, 21-25), the line returns error EAPG 999 with Line-Item Unassigned Flag 26.

• User Customizable Alternate Payment List option: EAPG 994 has historically been included as an option for end-users to designate inpatient only procedures for an alternate payment method. With the removal of all procedures from the EAPG inpatient only list, this option has been updated to permit users to add any CPT/HCPCS or EAPGs (of any EAPG type) to be designated for an "alternate payment" method. If the list is populated, EAPG 994 (User-Defined Alternate Payment Method Procedure) is returned with new Line-Item Unassigned Flag 25.

Revised output fields

Three additional values for the Line-Item Unassigned Flag (LIUF) are implemented:

- 24 HCPCS code reported is prior to or after policy coverage dates
- 25 Procedure for Alternate Payment (EAPG 994)
- 26 HCPCS or EAPG not significant procedure type cannot be added to user-defined inpatient only list

Additional logic changes

- Updated the qualifying diagnosis requirement for Behavioral Health/Substance Abuse Per Diem EAPG assignment: The logic is revised to look for a qualifying diagnosis in any diagnosis field (pdx, sdx, rvdx) where previously, the qualifying diagnosis was required to be in the pdx field.
- Updated logic for the telehealth flag assignment: The logic is updated to add flexibility for how telehealth services are recognized. The revised logic permits any service (HCPCS) reported with a telehealth modifier (95, GQ, GT, G0) or place of service indicating telehealth (2, or new value 10, effective 1/1/2022), to be identified with the telehealth services flag on the line output. This revised logic is in addition to recognizing telehealth services populated on the internal tables of the grouper for reportable and inherent telehealth.

Clinical logic changes

- Completed the removal of inpatient only procedures to be assigned to payable EAPGs which required the creation of six new EAPGs.
- Updates to drugs, laboratory, and pathology groups to account for cost, complexity, and current fee schedule trends. In particular, EAPG groups are created for drug screening tests, and an additional lab EAPG is added for advanced laboratory tests with high cost.
- Refinements were made to the following categories of EAPGs for improved clinical precision and to reflect currently observed outpatient claims reporting practices. The following list represents some of the more significant changes:
 - Breast surgery procedure groups

- Dental and Oral surgery procedure groups
- ENT surgery procedure groups
- Nine significant procedure EAPG groups had a type change, three of which were changed to ancillary type.
- Fifteen EAPG groups were added to the standard, default packaging list.
- Ninety-eight EAPGs had changes made to the clinical consolidation algorithm to improve the
 efficiency of outpatient grouping, based on observations in current outpatient claims data
 for claims with multiple significant procedures present.

The net effect of these changes is a more clinically precise and accurate assignment of EAPG groups aligned with current clinical practice, costs, and trends. Details describing these clinical changes may be found in subsequent sections of this document.

EAPG changes

For EAPG 3.17, there are 15 new EAPGs, six deleted EAPGs, and 21 revised EAPG descriptions. Note that any references to outpatient claims data set in the details substantiating changes in assignment of codes or the development of new EAPGs is associated with the review of source claims from the CMS OPPS CY 2020 data set, which contains a total of 90 million claims. For additional details related to the claims data set and usage for creation of relative weights, please see the Relative Weights section of this document (page 55).
