Why do I need to complete the survey?

ForwardHealth reimburses providers using a professional dispensing fee reimbursement rate based on a provider's annual prescription volume.

Providers who submit claims to ForwardHealth with National Drug Codes **are required** to attest their annual prescription volume so ForwardHealth can assign them a reimbursement rate.

What happens next?

ForwardHealth will notify providers of their rate assignments in March 2025. The new reimbursement rate assignments will be for dates of service on and after April 1, 2025.

If you don't submit a survey by **February 7, 2025**, ForwardHealth will assign you the lowest professional dispensing fee reimbursement rate.
