- 2. Speakers must submit a written copy of their testimony either prior to or at the meeting. Testimony copies may be submitted via email to Rita Hallett or mailed to the DHCF.
- 3. A maximum of 36 speakers will be permitted. Should all slots for spoken testimony become filled, parties are invited to submit written testimony for review and consideration by the committee. Written testimony should be submitted to Rita Hallett via email at <a href="mailto:haller@dhfs.state.wi.us">haller@dhfs.state.wi.us</a> or mailed to the Division of Health Care Financing, Attn: Rita Hallett, 1 W. Wilson Street, Room 350, Madison, WI 53702.

- 5. Speakers will be required to state name, address, organization represented and the drug name and class applicable to their testimony.
- 6. Speakers will be limited to a period of 5 minutes.
