On June 10, 2025, the Division of Quality Assurance, Bureau of Assisted Living concluded a verification visit at your facility to determine compliance with Wisconsin Administrative Code ch. DHS 83. As a result of this visit, there were no violations of DHS 83.

NOTICE OF REVISIT FEE

According to Wis. Stat. § 50.03(5g)(cm), if the Department imposes a sanction on, or takes other enforcement action against a community-based residential facility for violation of this subchapter or rules promulgated under it, and the Department subsequently conducts an onsite inspection to review the facility's action to correct the violation(s), the Department may impose a \$200 inspection fee on the community-based residential facility.

On June 10, 2025, a verification visit was concluded at Sienna Meadows of Oregon by the Division of Quality Assurance, Bureau of Assisted Living, to determine if the violation(s) contained in Statement of Deficiency (SOD) #0FXG11 were corrected. **Therefore, an inspection fee of \$200 is being assessed.**
