Changes to the Durable Medical Equipment Index/Maximum Allowable Fee Schedule

Effective for dates of service on and after November 1, 2000, Wisconsin Medicaid is making changes that will affect durable medical equipment (DME) coverage, policies, and limitations. These changes include adding new HCFA Common Procedure Coding System (HCPCS) procedure codes, deleting one code, and changing the life expectancy for some codes in the DME Index.

The Attachment to this *Update* lists the changes to the DME Index/Maximum Allowable Fee (MAF) Schedule. All abbreviations and column headings correspond to those listed in the current Medicaid DME Index (pages 2-4). Please make a note of these changes in your index.

Additions to Durable Medical Equipment Index HCPCS code list

The following HCPCS codes have been added to the DME Index:

 E1900—Synthesized speech augmentative communication device with dynamic display. This replaces W6808. L3807—WHFO; extension assist, with inflatable Palmer air support, with or without thumb extension.

Life expectancy changes

The life expectancy for the following item has been modified to 5 years:

E0277—Powered pressure-reducing air mattress.

Maximum allowable fee changes

The maximum allowable fee for the following rental item has been reduced:

 K0458—Heavy duty walker, without wheels, each (for recipient over 300 lbs).

The maximum allowable fees have changed for the following prosthetic devices:

- L2415—Addition to knee joint; cam lock (Swiss, French, Bail types), each joint.
- L2425—Addition to knee joint; disc or dial lock for adjustable knee flexion, each joint.
- L2430—Addition to knee joint; ratchet lock for active and progressive knee extension, each joint.

Description changes

The description has been revised for the following item:

 W6813—Specialized hydraulic or batteryoperated bath lift.

Deletion of HCPCS code from the Durable Medical Equipment Index

The following item has been deleted from the DME Index:

 W6808—Communicator, including accessories. The replacement code is E1900.

How to obtain the Durable Medical Equipment Index

The DME Index is available on Wisconsin Medicaid's Web site at www.dhfs.state.wi.us/medicaid.

The DME Index is also available on the Medicaid fiscal agent's bulletin board, EDS-EPIX. You may access EDS-EPIX using a personal computer, modem, and a communications software package. Refer to the Claims Submission section of the All-Provider Handbook for downloading instructions.

You may also purchase copies of the DME Index from Wisconsin Medicaid. Copies are available on paper, tape cartridge, microfiche, or diskette. Refer to the Claims Submission section of the All-Provider Handbook for ordering instructions.

This *Update* applies to fee-for-service Medicaid providers only. If you are a Medicaid managed care provider, contact your managed care organization (MCO) for more information about its billing procedures. Coverage is the same for Medicaid recipients in both fee-for-service and Medicaid managed care programs.

The *Wisconsin Medicaid and BadgerCare Update* is the first source of program policy and billing information for providers.

Although the *Update* refers to Medicaid recipients, all information applies to BadgerCare recipients also.
