The Wisconsin Medicaid companion document for the federal Health Insurance Portability and Accountability Act of 1996 (HIPAA)-compliant National Council for Prescription Drug Programs (NCPDP) 5.1 transactions is now available from Wisconsin Medicaid. This companion document provides information on Wisconsin Medicaid's requirements for NCPDP 5.1 billing and reversal transactions. A future Wisconsin Medicaid and BadgerCare Update will notify providers of the implementation dates.

The Wisconsin Medicaid companion document for the federal Health Insurance Portability and Accountability Act of 1996 (HIPAA)-compliant National Council for Prescription Drug Programs (NCPDP) 5.1 transactions is now available from Wisconsin Medicaid. Companion documents provide Wisconsin Medicaidspecific information that should be used with the national HIPAA-mandated Implementation Guides. Implementation Guides define the electronic format and values for each data element within an electronic transaction.

The NCPDP 5.1 companion document provides information on Wisconsin Medicaid's and SeniorCare's requirements for NCPDP 5.1 billing and reversal transactions. The NCPDP 5.1 is the format standard for retail pharmacy

drug claims. A future Wisconsin Medicaid and BadgerCare Update will notify providers of the implementation dates.
