## Announcing Wisconsin Medicaid's companion document for the HIPAA-compliant 835 Health Care Claim Payment/Advice

The Wisconsin Medicaid companion document for the federal Health Insurance Portability and Accountability Act of 1996 (HIPAA)-compliant 835 Health Care Claim Payment/Advice is now available from Wisconsin Medicaid. This companion document provides information for interpreting Wisconsin Medicaid's specific claim information on the 835 Health Care Claim Payment/ Advice transaction.

A future Wisconsin Medicaid and BadgerCare Update will notify providers of the implementation dates.

The Wisconsin Medicaid companion document for the federal Health Insurance Portability and Accountability Act of 1996 (HIPAA)-compliant 835 Health Care Claim Payment/Advice transaction, commonly referred to as the 835, is now available from Wisconsin Medicaid. Companion documents provide Wisconsin Medicaid-specific information that should be used with the national HIPAA Implementation Guides. Implementation Guides define the electronic format and values for each data element within an electronic transaction. This companion document provides information for interpreting Wisconsin Medicaid's specific claim information on the 835. The 835 is the electronic standard for the transmission of

payment/advice information. The 835 will be effective with the implementation of HIPAA. A future Wisconsin Medicaid and BadgerCare *Update* will notify providers of the implementation dates.
