Wisconsin Medicaid Electronic Claims and Web Prior Authorization Submission Deadlines and Holiday Schedule for 2004

Wisconsin Medicaid accepts electronic claims according to a standard submission schedule, except on holidays. Wisconsin Medicaid will be closed for business in recognition of certain holidays occurring in 2004. Both the electronic claims submission and holiday schedules are provided in the Attachment of this *Wisconsin Medicaid and BadgerCare Update*.

Electronic Claims Submission Schedule

Wisconsin Medicaid processes claims received throughout the week during the weekend processing cycle. The deadlines for submitting various types of electronic claims for weekend processing are in the Attachment of this *Wisconsin Medicaid and BadgerCare Update.*

Note: Processing may be delayed for tapes, cartridges, or transmissions that are damaged or contain bad data.

Wisconsin Medicaid 2004 November-December Holiday Schedule

Wisconsin Medicaid will be closed for business in recognition of certain holidays occurring in 2004. Refer to the Attachment for a list of these dates. Wisconsin Medicaid will not accept electronic claims on Thursday, November 25 and Friday, November 26, 2004, due to the Thanksgiving holiday. Electronic claims must be received by 5 p.m. Wednesday, November 24, 2004, to be included in the processing cycle that weekend. When a holiday occurs on a Friday such as December 24 or December 31, 2004, all claims received by 5 p.m. on Thursday, December 23 or Thursday, December 30, 2004, will process in the weekly cycle.

Providers who use a vendor or clearinghouse for electronic claims submission purposes should contact them for their holiday schedule.

Web Prior Authorization Request Submission

Prior authorization requests may be submitted by selected providers via the Web Monday through Friday from 8:00 a.m. to 5:00 p.m., excluding holidays. Refer to the Attachment for the holiday schedule.

Dial-up and Internet Access Lines

The dial-up and Internet access lines to the Division of Health Care Financing Electronic Data Interchange (EDI) Department are available Monday through Friday from 8:00 a.m. to 5:00 p.m., excluding holidays. Refer to the Attachment for the holiday schedule.
