In early 2005, Wisconsin Medicaid will accept prior authorization (PA) requests for additional service areas via the Medicaid Web site. Trainings on how to submit PA requests via the Web are scheduled for January and February 2005. Registration is required for the training sessions, but there is no registration fee for providers. Seating is limited so providers should register early.

Service Areas Added for Submitting Prior Authorization Requests Via the Web

In early 2005, Wisconsin Medicaid will accept prior authorization (PA) requests for additional service areas via the Medicaid Web site at *dhfs.wisconsin.gov/medicaid/*. Only information on the Prior Authorization Request Form (PA/RF) may be submitted via the Web for the added service areas. Providers will then submit service-specific PA attachments and additional supporting documentation on paper by mail or fax along with PA/RFs submitted via the Web.

Submitting PA requests via the Web is intended to reduce the number of requests returned to providers due to clerical errors or omissions and to establish initial grant dates for approved PA requests.

For providers currently submitting PA requests via the Web, the PA submission process will be similar to what is done today except that users will now have the option to submit supporting documentation on paper by mail or fax. Consequently, the training sessions (detailed later in this *Wisconsin Medicaid and BadgerCare Update*) may not be necessary for current users.

Future *Updates* will provide more information for new and current users about submitting PA requests via the Web. Refer to Attachment 1 of this *Update* for a complete list of the service areas for which PA requests may be submitted via the Web.

Note: Providers may continue to submit PA requests by mail or fax, or, when applicable, they may submit requests using the Specialized Transmission Approval Technology-Prior Authorization (STAT-PA) system.

Training Sessions Offered

In January and February 2005, Wisconsin Medicaid will provide free training sessions for the service areas listed in Attachment 1 regarding submitting PA requests via the Web. Refer to Attachment 2 for information regarding locations, dates, and times for the training sessions. Training locations, dates, and times are also listed on the Medicaid Web site at *dhfs.wisconsin.gov/medicaid/*.

While Wisconsin Medicaid encourages attendance, the training is not mandatory. Providers may submit PA requests via the Web even if they do not attend a training session.

Training Session General Topics

General topics that will be covered during the training sessions include:

- Registration procedures for Web PA users.
- Introduction to the Web PA application and tutorial. Refer to the Medicaid Web site at *dhfs.wisconsin.gov/medicaid/* for the Web PA tutorial. (Providers may access the tutorial and online Help screens for complete Web PA submission instructions even if they do not attend a training session or are not registered to submit Web-based PA requests.)
- Procedures for completing an online PA/RF.
- Procedures for submitting PA attachments and supporting documentation on paper by mail or fax for PA requests submitted via the Web.

Due to time constraints, the training sessions will *not* cover PA policy or paper PA submission. Providers with policy questions should contact Provider Services at (800) 947-9627 or (608) 221-9883 or a Wisconsin Medicaid professional relations representative. Refer to the Medicaid Web site for a list of professional relations representatives.

Registration for the Training Sessions

Providers need to register online or by telephone for the training sessions, but there is no registration fee. Registration will not be accepted by mail or fax. Providers are strongly encouraged to use online registration. Seating is limited, so providers should register early. Please keep in mind that meeting room temperatures vary; wear layered clothing to ensure comfort.

To Register Online

Providers may register online by going to the Medicaid Web site at *dhfs.wisconsin.gov/medicaid/* and doing one of the following:

- Choosing the "Find out What's New on the Wisconsin Medicaid Web Site" link on the Medicaid home page.
- Selecting "Providers" and choosing the "Training" link under "Reference/Tools."

After accessing one of the above, choose the "2005 Web Prior Authorization Training Registration" link for training information and the registration form. All fields on the online registration form are required. Once the form is completed, select "Register." Registrants will receive a training session confirmation number that they should keep for their records.

In January and February 2005, Wisconsin Medicaid will provide free training sessions for the service areas listed in Attachment 1 regarding submitting PA requests via the Web.

To Register by Telephone

Providers may also register for the training sessions by calling Provider Services at (800) 947-9627 or (608) 221-9883. Registrants will receive a confirmation number from the correspondent during the telephone call for the training session they select.

Questions Regarding Registration

If a provider has questions about his or her registration or if he or she is unable to attend a training session for which registration has been confirmed, the provider should call Provider Services. The provider should have his or her confirmation number available so the telephone correspondent can easily access his or her registration information.

Information Regarding Medicaid HMOs

This *Update* contains Medicaid fee-for-service information and applies to providers of services to recipients on fee-for-service Medicaid only. For Medicaid HMO or managed care policy changes, contact the appropriate managed care organization. Wisconsin Medicaid HMOs are required to provide at least the same benefits as those provided under fee-for-service arrangements.

The *Wisconsin Medicaid and BadgerCare Update* is the first source of program policy and billing information for providers.

Although the *Update* refers to Medicaid recipients, all information applies to BadgerCare recipients also.

Allowable Service Areas for Submitting Prior Authorization Requests Via the Web

Providers who indicate the following service areas in Element 3 of the Prior Authorization Request Form (PA/RF) may submit PA requests via the Web:

- 111 Physical therapy (PT).
- 112 Occupational therapy (OT).
- 113 Speech and language pathology (SLP).
- 114 Spell of illness (SOI) for PT.*
- 115 SOI for OT.*
- 116 SOI for SLP.*
- 117 Physician services, including rural health clinics and federally qualified health centers.*
- 118 Chiropractic.
- 120 Home health/nurses in independent practice/respiratory care services.
- 121 Personal care services.
- 122 Vision services.*
- 126 Psychotherapy and intensive in-home treatment service, a HealthCheck "Other Service."
- 127 Psychotherapy (Hospital).

- 128 Substance abuse services.
- 129 Mental health day treatment and child/adolescent day treatment, a HealthCheck "Other Service."
- 130 Durable medical equipment (DME) wheelchairs, accessories, or home health equipment.*
- 132 Disposable medical supplies.*
- 135 Ventilator services (hospital and nursing homes only).
- 136 Substance abuse day treatment.
- 139 DME oxygen and oxygen-related services, respiratory equipment, or exceptional supplies.*
- 140 DME orthotics, footwear, or prosthetics.*
