Rate Changes for Services Receiving Only Federal Funds

This *Wisconsin Medicaid and BadgerCare Update* describes changes to the federal share reimbursement rates for the following services:

- Community support programs.
- Crisis intervention.
- Outpatient mental health and substance abuse services in the home or community.

Changes to Federal Share

Effective for claims processed and paid on and after October 1, 2005, the federal share will decrease from 58.32 percent to 57.65 percent for the following services:

- Community support program (CSP) services.
- Crisis intervention services.
- Outpatient mental health and substance abuse services in the home or community.

Wisconsin Medicaid will pay only the federal share of the contracted rates for these services.

Contracted Rates Remain Unchanged

The contracted rates for CSP services, crisis intervention services, and mental health and substance abuse outpatient services in the home or community remain unchanged.

The contracted rate is the uniform rate determined by the Department of Health and Family Services and required by the Medicaid state plan.

Information Regarding Medicaid HMOs

This *Update* contains Medicaid fee-for-service policy and applies to providers of services to recipients on fee-for-service Medicaid only. For Medicaid HMO or managed care policy, contact the appropriate managed care organization. Wisconsin Medicaid HMOs are required to provide at least the same benefits as those provided under fee-for-service arrangements.

Note: Crisis intervention services are provided fee-for-service for all Medicaid recipients.

The *Wisconsin Medicaid and BadgerCare Update* is the first source of program policy and billing information for providers.

Although the *Update* refers to Medicaid recipients, all information applies to BadgerCare recipients also.
