1 Percent Reimbursement Rate Increase for Non-Institutional Services

Effective for dates of service on and after July 1, 2008, maximum allowable fees for the services listed in the Attachment of this *BadgerCare Plus Update* will increase 1 percent, as authorized by the Wisconsin state legislature in 2007-09 biennial budget, Wisconsin Act 20. The maximum allowable fees reflecting the new rates will appear on provider-specific maximum allowable fee schedules located on the Medicaid Web site at *dhs.wisconsin.gov/medicaid/*.

Rate increases apply for services provided to members enrolled in Wisconsin Medicaid and BadgerCare Plus. Certain providers may receive a targeted rate increase for selected procedure codes.

Providers are reminded about the following:

- They are required to submit claims to BadgerCare Plus for their usual and customary charges.
- BadgerCare Plus will reimburse providers the lesser of the billed amount or the maximum allowable fee, less any copayments required of members.

Information Regarding Managed Care

This *Update* contains fee-for-service policy and applies to services members receive on a fee-for-service basis only. For managed care policy, contact the appropriate managed care organization. BadgerCare Plus HMOs are required to provide at least the same benefits as those provided under fee-for-service arrangements.

The *BadgerCare Plus Update* is the first source of program policy and billing information for providers. All information applies to Medicaid and BadgerCare Plus unless otherwise noted in the *Update*.

ATTACHMENT Services Receiving 1 Percent Reimbursement Rate Increase Effective for dates of service on and After July 1, 2008

Physician and Related Services

- Ambulatory surgery center services.
- Anesthesiology, including services provided by anesthetists and anesthesiology assistants.
- Diagnostic testing.
- Family Planning Services.
- Laboratory services (not to exceed Medicare Part B rates).
- Medicine/surgical services.
- Vaccines, infusions, and other provideradministered drugs.
 - ✓ Reimbursement for the *administration* of vaccines, infusions, and other provideradministered drugs increases by one percent.
 - \checkmark Drug costs are not affected by the rate increase.
- X-ray services, including portable X-ray.

Note: The maximum allowable reimbursement per provider, per member, per day will increase to \$2,331.37. The limit pertains to most physician services and services provided by nurse midwives, nurse practitioners, oral surgeons, physician assistants, and podiatrists.

Medical Equipment, Supplies, and Related Services

- Disposable medical supplies.
- Durable medical equipment.
- Hearing aids (non-contracted hearing aids increase by one percent).

Mental Health and Related Services

- Adult mental health day treatment services.
- Child/adolescent day treatment services.
- Clozapine management services.
- In-home psychotherapy services for children.
- Outpatient mental health services.

Substance Abuse and Related Services

- Narcotic treatment services.
- Outpatient substance abuse services.
- Substance abuse day treatment services.

Therapy and Related Services

- Audiology services.
- Occupational therapy services.
- Physical therapy services.
- Rehabilitation agency occupational therapy and physical therapy services.

Other Services

- Ambulance services.
- Chiropractic services.
- Dental services.
- HealthCheck "Other Services."

- Specialized medical vehicle transportation services.
- Tuberculosis-related services.
