ForwardHealth Electronic Claims Submission **Deadlines and Holiday Schedule for 2008**

ForwardHealth processes electronic claims according to a standard submission schedule. ForwardHealth will be closed for business in recognition of certain holidays occurring in 2008, which will affect Electronic Data Interchange Helpdesk availability. The holiday schedule is provided in this ForwardHealth Update.

Electronic Claim Submission Schedule

ForwardHealth processes claims received throughout the week during a financial cycle. The deadlines for submitting electronic claims for the financial cycle are provided in the Attachment of this ForwardHealth Update.

ForwardHealth 2008 Holiday Schedule

ForwardHealth will be closed for business in recognition of certain holidays occurring in 2008. Refer to the Attachment for these dates. This year, ForwardHealth will be open Friday, November 28, the day after Thanksgiving.

ForwardHealth will accept electronic claims at any time, including all holidays. To be included in the financial cycle, all electronic claims must be received by:

- 4:00 p.m. on Mondays for Wisconsin Well Women
- 4:00 p.m. on Tuesdays for Wisconsin Chronic Disease Program.
- 4:00 p.m. on Fridays for Wisconsin Medicaid, BadgerCare Plus, and SeniorCare.

Providers who use a vendor or clearinghouse for electronic claims submission purposes should contact them for their holiday schedule.

ForwardHealth Portal

The ForwardHealth Portal is available Monday through Sunday, 24 hours a day, 7 days a week. Services available through the Portal are prior authorization (PA) submission, claim submission, and enrollment verification. The Portal can be accessed at www.forwardhealth.wi.gov/.
