Enddating a Prior Authorization Request

With the implementation of ForwardHealth interChange, providers must use the Prior Authorization Amendment Request, F-11042 (10/08), to enddate most prior authorization requests.

Prior Authorization Amendment Request

With the implementation of ForwardHealth interChange, providers are required to use the Prior Authorization Amendment Request, F-11042 (10/08), to enddate most prior authorization (PA) requests. ForwardHealth no longer accepts requests to enddate a PA request for any service, except drugs, on anything other than the Prior Authorization Amendment Request. Prior authorizations for drugs may be enddated by using the Specialized Transmission Approval Technology-Prior Authorization (STAT-PA) in addition to submitting a Prior Authorization Amendment Request.

Providers may submit a Prior Authorization Amendment Request on the ForwardHealth Portal or by fax or mail. If a request to enddate a PA is not submitted on the Prior Authorization Amendment Request, a letter will be sent to the provider stating that the provider is required to submit the request using the proper forms.

Information Regarding BadgerCare Plus HMOs

This ForwardHealth Update contains fee-for-service policy and applies to services members receive on a fee-for-service basis. For managed care policy, contact the appropriate managed care organization. HMOs are required to provide at least the same benefits as those provided under fee-for-service arrangements.

The ForwardHealth Update is the first source of program policy and billing information for providers.
