Clarification for Extraordinary Claims Submission for Professional Services

This ForwardHealth Update clarifies policy for providers when submitting extraordinary claims for inpatient hospital stays.

Submitting Extraordinary Claims for Inpatient Hospital Stays at the Time of HMO Enrollment

By contract, the BadgerCare Plus HMOs and Medicaid SSI HMOs are not financially responsible for enrollees who are hospitalized at the time of enrollment until an appropriate hospital discharge. Wisconsin Medicaid and BadgerCare Plus are responsible for paying all covered services for such hospitalized enrollees during hospitalization on a fee-for-service basis.

If the member was not enrolled in an HMO or SSI HMO at the time he or she was admitted to an inpatient hospital, but then enrolled in an HMO or SSI HMO during the hospital stay, all claims related to the stay (including physician claims) should be submitted for fee-for-service reimbursement. These claims (including physician claims) must include admittance and discharge dates.

For all professional claims for services rendered during the inpatient hospital stay, the provider is required to include the date of admittance and date of discharge in Element 18 of the paper 1500 Health Insurance Claim Form.

When submitting a paper extraordinary claim, providers must also include the following:

- A legible copy of the completed claim form, in accordance with billing guidelines.
- A letter detailing the problem, any claim denials, and any steps taken to correct the situation.

Information Regarding Managed Care Organizations

This ForwardHealth Update contains fee-for-service policy and applies to services members receive on a fee-for-service basis only.
