Electronic Health Record Incentive Program Information Sessions Offered for Providers, Hospitals, and Staff

This *ForwardHealth Update* provides information regarding the Electronic Health Record Incentive Program and free Webinar information sessions for eligible providers, eligible hospitals, and their staff.

Background

The Electronic Health Record (EHR) Incentive Program was established under the 2009 Federal Stimulus Bill to encourage eligible health care providers and hospitals to adapt and show meaningful use of certified EHR technology.

The Centers for Medicare and Medicaid Services has already paid over \$37 million to participating hospitals and providers through the EHR Incentive Programs. Medicare and Medicaid have separate EHR incentive programs and providers may register to participate in either the Medicare or Medicaid EHR incentive programs, but not both.

The Wisconsin Medicaid EHR Incentive Program is scheduled to begin the registration process in the summer of 2011 and will begin making payments to all registered, eligible providers and hospitals within 45 days of successfully completing the program's first-year requirements.
