## Wisconsin Well Woman Program Training Available

In August and September 2011, ForwardHealth will offer Wisconsin Well Woman Program (WWWP) training sessions. These sessions are directed to WWWP providers; however, local coordinating agency staff can benefit from attending as well. Reporting forms will be the primary focus of these sessions, along with discussion of other common questions and issues. This *ForwardHealth Update* provides the training session schedule, covered topics, and registration information.

### Wisconsin Well Woman Program Training Available

  - ✓ Cervical Cancer Diagnostic and Follow-Up Report (DRF), F-44729 (10/08).
- Portal enhancements.

- Discussion of other common questions and issues for WWWP providers.
- ForwardHealth resources.

#### Training Registration

Providers are required to register prior to attending any of the scheduled training sessions. Providers with Internet access are strongly encouraged to register online on the Provider Trainings page of the ForwardHealth Portal at [www.forwardhealth.wi.gov/](http://www.forwardhealth.wi.gov/). Providers without Internet access may register by calling Provider Services at (800) 947-9627. Registrants will receive a training session confirmation number that they should keep for their records.

Providers who have questions about registration or are unable to attend a session for which registration has been confirmed should call Provider Services and have their confirmation number available.

#### Training Session Webcast

A training session will be recorded and posted to the Web for on-demand viewing after the scheduled sessions are complete. Those who cannot attend a session in person may view the recorded session at their convenience. Providers do not need to register to view the Webcast session. To access

the recorded training session, go to the Trainings page in the Provider area of the Portal and, under Current Webcast Training Sessions, click the WWP Trainings link.

*Note:* The training presentation handout will be available for download from the Portal. Providers are encouraged to print a copy of the presentation handout prior to viewing the Webcast.
