Affected Programs: BadgerCare Plus, Medicaid To: Hospice Providers, HMOs and Other Managed Care Programs

Hospice Reimbursement Rate Changes

Effective for dates of service on and after October 1, 2011, Wisconsin Medicaid and BadgerCare Plus hospice service reimbursement rates have changed.

Wisconsin Medicaid and BadgerCare Plus hospice reimbursement rates are based on hourly and per diem rates established by the federal government for all covered hospice services. Effective for dates of service (DOS) on and after October 1, 2011, Wisconsin Medicaid and BadgerCare Plus hospice service reimbursement rates have changed.

The Attachment of this *ForwardHealth Update* includes the new hospice rates that are effective for DOS on and after October 1, 2011. Nursing home room and board rates are not impacted by these hospice reimbursement rate changes.

Wisconsin Medicaid will automatically adjust claims for services provided on and after October 1, 2011, if the claims were reimbursed at the previous reimbursement rate. Reimbursement will be adjusted to the maximum amount allowed or the billed amount, whichever is less. Using the banner page of the Remittance Advice, ForwardHealth will announce when it completes the adjustments.

Information Regarding Managed Care Organizations

This *Update* contains fee-for-service policy and applies to services members receive on a fee-for-service basis only. For managed care policy, contact the appropriate managed care organization. Managed care organizations are required to provide at least the same benefits as those provided under fee-for-service arrangements.

The *ForwardHealth Update* is the first source of program policy and billing information for providers.

Wisconsin Medicaid, BadgerCare Plus, SeniorCare, and Wisconsin Chronic Disease Program are administered by the Division of Health Care Access and Accountability, Wisconsin Department of Health Services (DHS). The Wisconsin Well Woman Program is administered by the Division of Public Health, Wisconsin DHS.
