## **New Training Opportunities for Providers**

Beginning in April 2013, ForwardHealth will offer a series of regularly scheduled real-time, Web-based training sessions for all providers. These training opportunities, called the Brown Bag Lunch Series, will be held on the second and fourth Tuesday of each month and will last approximately 30 minutes. The topics covered in these sessions will address common provider issues and questions. Each session will offer providers a great opportunity to learn and ask questions about that week's topic with the added convenience of a small time commitment and being able to attend without leaving the office. The training schedule and topic for each session is available on the Trainings page of the ForwardHealth Portal.

## **Participating in a Training Session**

Unlike other ForwardHealth training sessions, providers do not need to register to participate in the Brown Bag Lunch Series. Each session will accommodate the first 50 participants who access the session. Associated training materials and the telephone number and access code required for participating in these sessions will be available on the Trainings page of the Portal at least one week before the training session.

## **Preparation for the Sessions**

These real-time, Web-based sessions will be facilitated through HP® Virtual Room. Providers who have not yet participated in a Virtual Room session are encouraged to review the "Information Regarding HP® Virtual Room" document.
