Personal Care Providers Can Now Upload Personal Care Screening Tool Reports Using the ForwardHealth Portal

Effective on and after February 14, 2014, personal care providers can use the ForwardHealth Portal to upload Personal Care Screening Tool reports for submission with prior authorization requests.

Effective on and after February 14, 2014, personal care providers can upload full Personal Care Screening Tool (PCST) reports, F-11133 (01/11), and PCST Summary Sheet reports for submission with prior authorization (PA) requests on the ForwardHealth Portal at *www.forwardhealth.wi.gov/*.

Providers are reminded to complete the Personal Care Allocation Information page of the PCST report before uploading the report to the Portal. On both the full and summary PCST reports, providers are required to enter the billing provider's name, address, and National Provider Identifier or Medicaid provider number, and to indicate whether or not the member will be served under a caseshare arrangement. The uploaded report must contain the required information or the PA request will be returned to the provider.

Note: As a reminder, providers requesting more time than is allocated by the PCST report are required to submit a copy of the full PCST report with the PA request (the full report includes the Summary Sheet). Providers requesting an amount equal to or less than the time allocated on the PCST

report are only required to submit a copy of the PCST Summary Sheet with the PA request.

Providers should not submit more than one PCST report to ForwardHealth regardless of the submission method (fax, mail, Portal).

Information Regarding Managed Care Organizations

This *ForwardHealth Update* contains fee-for-service policy and applies to services members receive on a fee-for-service basis only. For managed care policy, contact the appropriate managed care organization. Managed care organizations are required to provide at least the same benefits as those provided under fee-for-service arrangements.

The *ForwardHealth Update* is the first source of program policy and billing information for providers.
