## ForwardHealth International Classification of Diseases, 10th Revision, Clinical Modification and International Classification of Diseases, 10th Revision, Procedure Coding System Implementation Is Postponed

Federal legislation has postponed the *International Classification of Diseases, 10th Revision, Clinical Modification* (ICD-10-CM) and *International Classification of Diseases, 10th Revision, Procedure Coding System* (ICD-10-PCS) compliance date. In response to the mandate, ForwardHealth will be implementing ICD-10 no earlier than October 1, 2015.

Federal legislation has postponed the compliance date for the *International Classification of Diseases, 10th Revision, Clinical Modification* (ICD-10-CM) and *International Classification of Diseases, 10th Revision, Procedure Coding System* (ICD-10-PCS) code sets. In response to the mandate, ForwardHealth will be implementing ICD-10 no earlier than October 1, 2015. Additionally, Brown Bag Lunch Series online training sessions for ICD-10 are cancelled and will be rescheduled at a later date.

ForwardHealth will continue to actively assess ICD-10 impacts. Stakeholders who conduct business with ForwardHealth are encouraged to do the same to ensure readiness for the new compliance date. Information about ForwardHealth's transition to ICD-10, including new information and revised dates, will be published in future ForwardHealth Updates and/or published to the ICD-10 Code

ForwardHealth will continue to use the ICD-10 Project Information e-mail subscription option as a method to communicate important project information throughout its transition to ICD-10, including post-implementation. All interested parties are reminded to register in order to receive targeted ICD-10 e-mail subscription messages from ForwardHealth. The ICD-10 Code Set Transition Home Page features a Register to Receive Information from ForwardHealth About ICD-10 quick link that instructs providers how to register.

Information published in the February 2014 Update (2014-11), titled "ForwardHealth's Transition to International Classification of Diseases, 10th Revision, Clinical Modification and International Classification of Diseases, 10th Revision, Procedure Coding System Code Sets," is still relevant for project background, preparation, and communications information; however, references to the October 1, 2014, date are no longer current.

The ForwardHealth Update is the first source of program policy and billing information for providers.
