In September 2014, ForwardHealth will offer regional training sessions for chiropractors regarding ForwardHealth Portal functionality specific to their business needs. ## **Covered Topics**

The following topics will be covered at the training sessions:

- Claims.
  - ✓ Claim functionality on the Portal.
  - ✓ Common reasons for claim denials.
- Covered services.
  - Determining covered services, including allowable codes.
  - ✓ Maximum allowable fee schedule.
- Member enrollment verification, including the difference between fee-for-service and state-contracted HMO coverage.

- Prior authorization (PA).
  - ✓ Prior authorization functionality on the Portal.
  - ✓ Services requiring PA.
- Provider enrollment and ongoing responsibilities.
  - ✓ Difference between group and individual enrollment.
  - ✓ Documentation requirements.
  - ✓ Keeping information current, including updating information via the demographic maintenance tool on the Portal.
- Provider resources overview, including finding information in the ForwardHealth Online Handbook.
- Spell of illness overview.

## Registration

Registration is required prior to attending the training sessions. To register online, providers should refer to the Trainings page on the Portal. Providers may also register by calling Provider Services at (800) 947-9627. Registrants will receive a training session confirmation number that they should keep for their records. Providers who have questions about registration or are unable to attend a session for which registration has been confirmed should call Provider Services and have their confirmation number available.

The ForwardHealth Update is the first source of program policy and billing information for providers.

Wisconsin Medicaid, BadgerCare Plus, SeniorCare, and Wisconsin Chronic Disease Program are administered by the Division of Health Care Access and Accountability, Wisconsin Department of Health Services (DHS).
