## **Procedure Code Changes for Influenza** Vaccinations

Effective for dates of service on and after July 1, 2014, ForwardHealth will reimburse providers for three additional *Current Procedural Terminology* (CPT) procedure codes for influenza vaccinations.

Effective for dates of service (DOS) on and after July 1, 2014, ForwardHealth will reimburse providers for three additional *Current Procedural Terminology* procedure codes for influenza vaccinations:

- 90661 (Influenza virus vaccine, derived from cell cultures, subunit, preservative and antibiotic free, for intramuscular use).
- 90673 (Influenza virus vaccine, trivalent, derived from recombinant DNA (RIV3), hemagglutinin (HA) protein only, preservative and antibiotic free, for intramuscular use).
- 90688 (Influenza virus vaccine, quadrivalent, split virus, when administered to individuals 3 years of age and older, for intramuscular use).

Providers should resubmit claims for influenza immunizations that may have been denied for DOS on and after July 1, 2014.

## Tracking Influenza Immunizations in the Wisconsin Immunization Registry

Providers are strongly encouraged to enter administered immunizations into the Wisconsin Immunization Registry (WIR). For more information about the WIR, refer to the WIR Web site at *www.dbs.wisconsin.gov/immunization/WIR.htm*.

## Information Regarding Managed Care Organizations
