Upcoming Trainings for the All Patient Refined Diagnosis Related Group System

ForwardHealth will be offering provider trainings on the upcoming All Patient Refined Diagnosis Related Group (APR DRG) classification system. ForwardHealth will be implementing the APR DRG classification system for the pricing of inpatient hospital fee-for-service claims, Medicare crossover claims, and HMO encounters with dates of discharge or "To" dates of service (DOS) on and after January 1, 2017.

Upcoming Trainings

In October 2016, ForwardHealth will be offering provider training sessions on the All Patient Refined Diagnosis Related Group (APR DRG) classification system.

ForwardHealth will implement the APR DRG classification system for the pricing of inpatient hospital fee-for-service claims, Medicare crossover claims, and HMO encounters with dates of discharge or "To" dates of service (DOS) on and after January 1, 2017. The implementation will impact the reimbursement of inpatient hospital services provided to members enrolled in Wisconsin Medicaid, BadgerCare Plus, Wisconsin Chronic Disease Program (WCDP) Adult Cystic Fibrosis, and WCDP Chronic Renal Disease. Inpatient hospital providers, financial and billing staff, and billing vendors are encouraged to participate in these training sessions.

As a reminder, the implementation of APR DRG will also impact the pricing for HMO encounters for members enrolled in Wisconsin Medicaid or BadgerCare Plus. The training sessions listed in this *ForwardHealth Update* will be

applicable to fee-for-service providers only. Providers in an HMO network should contact their contracted HMOs for information about their APR DRG implementation, which may differ from fee-for-service. ForwardHealth will continue to communicate APR DRG information to HMOs at the monthly HMO Encounter Technical meetings.

Covered Topics

The following topics will be covered at the APR DRG system training sessions:

- The APR DRG methodology, including information on adjustments for the Wisconsin-specific grouper
- All Patient Refined Diagnosis Related Group reimbursement and policy, including information on the following:
 - **ü** Rate setting
 - **ü** Modeling
 - **ü** Policy changes
- Medicaid Management Information System and APR DRGs, including information on the following:
 - **ü** Claims submission
 - **ü** Processing claims
 - **ü** System changes and impacts, including the following:
 - Changes to ForwardHealth Portal provider panels
 - Changes to Remittance Advice and Explanation of Benefits codes
 - **ü** Testing

Upcoming Training Opportunities

ForwardHealth will offer five separate training sessions for the APR DRG system trainings: four in-person training sessions and one real-time, web-based training session.

In-Person Trainings

In-person trainings will be held in four locations across the state from October 12–October 19. See the Attachment of this *Update* for the dates, locations, and additional details about these in-person training sessions. Registration is required prior to participating in the in-person training sessions.

ForwardHealth will offer a real-time, web-based training session via MyRoom™ on October 26. Providers do not need to register to participate. Associated training materials and access code required for participating in this training session will be available on the Trainings page of the Portal at least one week before the training session.
