# Eligibility Information Immediately Available in interChange for Real-Time Eligibility Determinations

ForwardHealth has implemented real-time access to eligibility information in interChange for applicants who receive a real-time eligibility determination for BadgerCare Plus and/or Family Planning Only Services. Revised temporary identification cards for BadgerCare Plus and Family Planning Only Services will be available beginning September 24, 2016, to reflect this change.

## Enhancement to Real-Time Eligibility Determination Process

ForwardHealth is able to complete real-time eligibility determinations for BadgerCare Plus and/or Family Planning Only Services applicants who meet pre-screening criteria and whose reported information can be verified in real time when they apply in ACCESS Apply for Benefits at access.mi.gov/. Once an applicant is determined eligible through the real-time eligibility process, he or she is considered eligible for BadgerCare Plus and/or Family Planning Only Services and will be enrolled for 12 months, unless changes affecting eligibility occur before the 12-month period ends.

As an enhancement to the real-time eligibility process, ForwardHealth has implemented a web service that will transmit eligibility information to interChange in real time when a person applying for BadgerCare Plus and/or Family Planning Only Services in ACCESS receives a real-time eligibility determination. As a result, eligibility information

will be available immediately through the ForwardHealth Portal for almost all applicants who receive a real-time eligibility determination for BadgerCare Plus and/or Family Planning Only Services.

### **Temporary Identification Cards**

For applicants who receive a real-time eligibility determination, a PDF titled "Your Health Care Results" will be created in ACCESS. This PDF will include eligibility information for each applicant. For applicants who are eligible in the current month or the next month, the PDF will include a temporary identification (ID) card for BadgerCare Plus and/or Family Planning Only Services.

A revised temporary ID card will be available beginning September 24, 2016, to reflect the real-time availability of eligibility information. The temporary ID card will be valid for the dates listed on the card and will allow the member to receive immediate health care or pharmacy services. A temporary ID card is considered a valid ForwardHealth ID card for the timeframe listed on the card. Refer to Attachments 1 and 2 of this ForwardHealth Update for sample temporary ID cards.

Note: Members who were previously enrolled in BadgerCare Plus, Medicaid, or Family Planning Only Services will not automatically receive a new permanent ForwardHealth ID card. If a member still has his or her ForwardHealth ID card,

the member should use that card. If a member does not still have his or her ForwardHealth ID card, the member should request a new card through his or her MyACCESS account or by calling Member Services at 800-362-3002.

### **Eligibility Verification**

When a member is determined eligible for BadgerCare Plus and/or Family Planning Only Services through the real-time eligibility process, providers will be able to see the member's eligibility information in Wisconsin's Enrollment Verification System (EVS) in real time. Providers should verify eligibility through EVS prior to providing services. On rare occasions, it may take up to 48 hours for eligibility information to be available through interChange. In such instances, if a member presents a valid temporary ID card, the provider is still required to provide services, even if eligibility cannot be verified through EVS.

#### **Good Faith Claims**

If a member's eligibility cannot be verified through EVS, but the member presents a valid temporary ID card, the provider should make a photocopy of the member's temporary ID card and wait up to one week to submit a claim to ForwardHealth. If the claim is denied with an enrollment-related explanation of benefits code, the provider should contact Provider Services at 800-947-9627 for assistance. A good faith claim may be submitted when a claim is denied due to a discrepancy between the member's enrollment information in the claims processing system and the member's actual enrollment.

The ForwardHealth Update is the first source of program policy and billing information for providers.

Wisconsin Medicaid, BadgerCare Plus, SeniorCare, and Wisconsin Chronic Disease Program are administered by the Division of Health Care Access and Accountability, Wisconsin Department of Health Services (DHS). The Wisconsin AIDS Drug Assistance Program and the Wisconsin Well Woman Program are administered by the Division of Public Health, Wisconsin DHS.

#### To the Provider
