Clarification of Increased Reimbursement and Changes to Claims Submission Requirements for Outpatient Behavioral Health Services

As announced in the December 2017 ForwardHealth Update (2017-41), titled "Increased Reimbursement and Changes to Claims Submission Requirements for Outpatient Behavioral Health Services," effective for dates of services (DOS) on and after January 1, 2018, ForwardHealth has simplified the reimbursement rate structure for outpatient behavioral health services.

Rate Structure

ForwardHealth has revised the reimbursement rates since the publication of *Update* 2017-41 to more accurately reflect reimbursement according to a provider's qualifications and the type of treatment provided. Refer to Attachment 1 of this *Update* for the behavioral health provider reimbursement modifiers crosswalk table.

Reimbursement Rates

Effective for DOS on and after January 1, 2018, ForwardHealth increased reimbursement rates for outpatient behavioral health services. The maximum allowable fee schedules on the ForwardHealth Portal have been updated as of January 1, 2018. Several rates published in *Update* 2017-41 were not correct. Refer to Attachment 2 for the full list of the impacted Healthcare Common Procedure Coding System procedure codes on the mental health and substance abuse

fee schedules with appropriate modifiers and their established rates.
