# Family Care and IRIS Expand in Adams County

Beginning July 1, 2018, the Family Care and IRIS (Include, Respect, I Self-Direct) programs will start in Adams County, concluding statewide expansion of Family Care and IRIS. On July 1, 2018, participants in the Community Options Program Waiver (COP-W) and Community Integration Program (CIP) in Adams County will transition to Family Care or IRIS programs on a schedule based on state guidelines. This *ForwardHealth Update* details the Adams County expansion and includes information about the provision of Family Care and IRIS services.

Family Care and IRIS, two of Wisconsin's flexible long-term care programs, offer participants access to long-term care services. To enroll in Family Care or IRIS, a person must be eligible for Wisconsin Medicaid and determined functionally eligible for long-term care services.

### **Rendering Family Care Services**

In order to render Family Care services, providers must meet the following requirements:

- Be a part of a managed care organization's (MCO) provider network or an Indian Health Care Provider.
- Ensure services are authorized by the MCO before they are rendered to a Family Care member.

### **Certified Family Care MCOs**

The following MCOs will offer services in Adams County:

## **Rendering IRIS Services**

In order to render IRIS services, providers must meet the following requirements:

- Meet the provider qualifications prescribed in the IRIS
  1915(c) Home and Community Based Services waiver as
  outlined in the IRIS Service Definition Manual,
  P-00708B (04/2018), available on the Wisconsin
  Department of Health Services (DHS) website at
  www.dbs.wisconsin.gov/publications/p00708b.pdf.
- Be selected by the participant to provide services.
- Agree to render the services at the quantity and price negotiated with the participant.
- Complete and submit the Medicaid waiver provider agreement and other provider paperwork to the participant's fiscal employer agent.
- Ensure that services are authorized by the IRIS consultant before they are rendered to an IRIS participant.

## **Certified IRIS Consultant Agencies**

IRIS consultant agencies provide an IRIS consultant to the IRIS program participant. The IRIS consultant role and responsibility focuses on supporting the participant's self-direction, which includes enrollment, service planning, monitoring health and safety, and continued eligibility.

## Verifying Member or Participant Enrollment

Providers should **always** verify the person's enrollment prior to rendering services since a person can enroll in or disenroll from Family Care or IRIS **at any time**. Providers can verify member enrollment in Family Care and Partnership through any of the following methods:

- WiCall (ForwardHealth's Automated Voice Response system) at 800-947-3544
- An enrollment verification vendor
- The secure MCO area of the ForwardHealth Portal (For more information regarding enrollment verification on the Portal, refer to the Enrollment Verification User Guide available on the Portal at www.forwardhealth.wi.gov/ WIPortal/content/Provider/userguides/userguides.htm.spage.)

Providers can verify participant enrollment in IRIS by contacting the assigned IRIS consultant agency.
