CHANGES TO BLOOD PRESSURE MONITORING EQUIPMENT REQUIREMENTS

ForwardHealth is removing restrictions from and clarifying requirements for coverage of blood pressure monitoring equipment.

Blood Pressure Monitors

Members can now receive blood pressure cuffs, automatic blood pressure monitors, and sphygmomanometers without requiring documentation of daily use when prescribed by providers acting within the scope of their practice.

Medical necessity for blood pressure equipment must be documented in a member's records. ForwardHealth reimburses only for services that are medically necessary, as defined under Wis. Admin. Code § DHS
101.03(96m). ForwardHealth may deny or recoup payment if a service fails to meet Medicaid medical necessity requirements.

Remote Blood Pressure Monitoring

ForwardHealth has **not** changed the requirements for remote blood pressure monitoring. Dispensing blood pressure equipment to members is separate from remotely monitoring their blood pressure.

Documentation Retention

Providers are reminded that they must follow the documentation retention requirements per Wis. Admin. Code § <u>DHS 106.02(9)</u>. Providers are required to produce or submit documentation, or both, to the Wisconsin Department of Health Services (DHS) upon request. Per Wis. Stat. § <u>49.45(3)(f)</u>, providers of services shall maintain records as required by DHS for verification of provider claims for reimbursement. DHS may audit such records to verify the actual provision of services and the appropriateness and accuracy of claims. DHS may deny or recoup payment for services that fail to meet these requirements. Refusal to produce documentation may result in denial of submitted claims, recoupment of paid claims, application of intermediate sanctions, or termination from the Medicaid program.

Information Regarding Managed Care Organizations

This ForwardHealth Update applies to blood pressure monitoring equipment that members receive on a fee-for-service basis and through BadgerCare Plus, Medicaid SSI, and other managed care programs. For information about managed care implementation of the updated policy, contact the appropriate managed care organization (MCO). MCOs are required to provide at least the same benefits as those provided under fee-for-service arrangements.
