## Wraparound Milwaukee Is Now a Managed Care Program

---

### What is Wraparound Milwaukee?

Effective March 1, 1997, Wraparound Milwaukee (known as "Wraparound") becomes a Medicaid managed care program. Wraparound is a system of coordinated mental health care and social services designed to respond to complex needs of children with serious emotional disturbances and their families. Wraparound has provided services since 1994.

### Wraparound provides only mental health, AODA, and case management services

Wraparound and its provider network provide only mental health, AODA (alcohol or other drug abuse), and case management services to Wraparound Milwaukee enrollees. This includes inpatient hospital treatment for psychiatric or AODA conditions. For children enrolled in Wraparound, Wisconsin Medicaid reimburses Wraparound only for these services. ### Wisconsin Medicaid pays for all other services on a fee-for-service basis

Other than Wraparound services (mental health, AODA, and case management

services), Wisconsin Medicaid reimburses for all other services, including prescription drugs, on a fee-for-service basis. Children enrolled in Wraparound are not enrolled in Medicaid HMOs and always receive other Medicaid services on a fee-for-service basis.

### How to identify Wraparound enrollees

Wisconsin Medicaid issues a yellow Medicaid ID card to children enrolled in Wraparound. In the "other coverage" field, the ID card will state "Mental health services only through WAM." (On the card, "WAM" stands for Wraparound.)

Even though a child is identified as a Wraparound enrollee, providers may provide any Medicaid-covered service, other than mental health, AODA, and case management services, on a fee-for-service basis.

### Contact information
