## Waiver allows Wisconsin Partnership programs to cover all Medicaid services

Wisconsin Partnership special managed care programs will cover *all* Medicaid services pursuant to the Medicaid Section 1115 Waiver. This change affects the following special managed care organizations in Dane County:

- Elder Care of Dane County, Inc. (EC)
   Effective January 1, 1999, Elder Care
   Partnership will cover all Medicaid services.
   Elder Care Partnership serves elderly
   people who are eligible for nursing home
   care, are over age 55, and live in Dane
   County. Enrollees have the code
   "MCPECO" printed on their ID card.
   Currently Elder Care Partnership covers all
   Medicaid services except inpatient and
   outpatient hospitalizations, x-rays, and
   laboratory services, which remain billable
   fee-for-service. For more information about

- Community Living Alliance, Inc. (CLA) Effective May 1, 1999, CLA/Partnership will cover all Medicaid services. CLA/ Partnership program serves people with physical disabilities who are ages 16 to 65 living in Dane County. Enrollees have the code "MCPCLA" printed on their Medicaid ID card. Currently CLA/Partnership covers all Medicaid services except inpatient and outpatient hospitalizations, x-rays, laboratory services, and prenatal care coordination,

Effective January 1, 1999, it will be the responsibility of Elder Care of Dane County, Inc. to cover services previously billed directly to Wisconsin Medicaid fee-for-service for Elder Care Partnership enrollees. Effective May 1, 1999, it will be the responsibility of CLA to cover services previously billed directly to Wisconsin Medicaid fee-for-service for CLA/Partnership enrollees. Providers in the respective organization's network or with prior approval from the respective organization are to bill claims for these services directly to the special managed care organizations' fiscal agent at the following address:
