## Birth to 3 and natural environments

Wisconsin Medicaid provides this information on Birth to 3 Program changes because many Birth to 3 children are also Medicaid recipients.

This describes Wisconsin Birth to 3 (B-3) Program requirements [per Code of Federal Regulations (CFR) (34 CFR Part 303)] related to the provision of services in the child's natural environment and Medicaid procedures to support these services. The October 1998 *Medicaid Update* described the responsibility of Medicaid providers to promptly refer children with developmental delays or disabilities who are aged 36 months or younger to county B-3 (early intervention) Programs to determine eligibility.

#### **Requirements for health care providers**

For children in the Birth to 3 (B-3) Program, federal regulations require that providers deliver all services identified in a child's Individualized Family Service Plan (IFSP) in the child's "natural environment," unless otherwise specified in the IFSP. "Natural environment" is defined in both 34 CFR Part 303 and HFS 90, Wis. Admin. Code, as "settings that are natural or normal for the child's age peers who have no disability." Services are provided in the places where the child's family and other caregivers can be present and learn therapy approaches. Carryover also occurs when approaches are integrated into the day-to-day activities of the child and family. Birth to 3 regulations require that IFSP services be provided in natural environments to the maximum extent appropriate. IFSP services may be provided in a setting other than a natural environment only when outcomes cannot be satisfactorily achieved for the child in his or her natural environment. The policies in this Update apply to both fee-for-service and HMO network providers.

#### Natural environment requirements for the Individualized Family Service Plan

The IFSP provides a description of the outcomes, strategies, supports, and services appropriate to meet the needs of the child and family, along with the natural environment settings where services will be provided. The child's IFSP team determines which settings are appropriate for the delivery of early intervention services based on the needs of the child. When services are not provided in the child's natural environment, the IFSP must include a justification of the extent, if any, to which services will not be provided in a natural environment.

## Wisconsin Medicaid prior authorization requests for children aged birth to three

Effective with this Update, providers submitting prior authorization (PA) requests for children from birth to age three are required to provide additional information as follows:

• When submitting an initial PA request for a child aged birth to 36 months, submit a copy of the child's current IFSP. With written

consent from the parents, you may obtain a copy of a child's IFSP by contacting the county B-3 Program where the child receives B-3 services.

- If a current valid IFSP has already been submitted with a previous PA, reference the PA number where the IFSP can be found.
- If the IFSP has been changed or updated, submit it with the PA request.
- If the PA request is being submitted without an IFSP, provide a statement of justification for why the child has no IFSP.

## Wisconsin Medicaid reimbursement for travel time and expenses for Individualized Family Service Plan services

Under a long-standing policy, Wisconsin Medicaid does not separately reimburse providers for travel time and expenses related to delivery of services, including services provided in the natural environment. Reimbursement for such overhead costs is included in the reimbursement of the face-to-face professional service.


