Summary of changes for 3M[™] Enhanced Ambulatory Patient Grouping (EAPG) System

For licensees of the 3M[™] Enhanced Ambulatory Patient Grouping (EAPG) System, this document identifies changes for version 3.18, effective January 1, 2023.

The EAPG grouper EAPG version 3.18 contains versions 3.12 through 3.18; seven years' worth of grouper versions are retained (2016 through 2023). Additionally, grouper versions 3.10 and 3.11 remain in the grouper for historical claims processing, but do not receive code updates.

Each year, 3M revises the EAPG patient classification logic for two reasons:

- To accommodate changes in health care code sets, most importantly the International Classification of Diseases, Version 10, Clinical Modification (ICD-10-CM), the Current Procedural Terminology (CPT®), and the Healthcare Common Procedure Coding System (HCPCS). The U.S. Department of Health and Human Services (DHHS) usually does an annual update to the ICD-10-CM code set each October 1 and April 1. The American Medical Association makes its major update to the CPT code set each January 1 and makes some additional updates quarterly. DHHS updates the HCPCS code set quarterly. 3M releases quarterly updates of the EAPG grouper to reflect code set updates made during the year.
- 2. 3M continually performs research to enhance the clinical precision of the EAPG logic, that is, how patients are classified into one or more EAPGs per ambulatory care visit. These enhancements are implemented each year with the January 1 release.

As shown in Table 1, between October 1, 2021, and January 1, 2023, there is a net increase of 891 ICD-10-CM diagnosis codes, or 2.27%. Table 2 shows a net increase of 360 CPT®/HCPCS codes or 2.18%.

In addition to changes to reflect modifications in the national diagnosis and procedure code sets, 3M is making several enhancements to the clinical logic. In updating the clinical logic, changes have been made to improve the precision of the clinical logic by considering customer recommendations, shifts in coding, changes in practice, and economic cost shifts.

As coding systems are revised, and new technology and advances in medicine occur, the need for new EAPG groups, as well as code assignment changes to EAPG groups, are reviewed and evaluated each year. New EAPG groups may be added, and obsolete groups may be deleted. Some procedural EAPG groups have no procedure codes assigned (EAPG 409, 4001), however, the groups are maintained for future use. Modifications occur due to code assignment changes, and groups are reviewed for clinical homogeneity across current industry trends, claim reporting frequency and reimbursement. A comparison table of the EAPG changes between versions 3.17 and 3.18 is provided in Table 3.

Updated logic for EAPG 999 (Unassigned)

With the release of version 3.18 (effective 1/1/2023), if EAPG 999 is assigned, the packaging flag and any other line-item grouping output flags are cleared out and the line item is unassigned. The following fields: EAPG, EAPG Type, and EAPG Category, reflect unassigned values. The list of Line-Item Unassigned Flag values are noted below.

Summary of clinical refinements to the EAPG grouper

A summary of changes to the EAPG grouper under version 3.18 is provided below; additional detail is provided under subsequent sections. For detailed lists of these changes, see the attached Annual Summary of Changes spreadsheet.

- Updates to drugs, laboratory, and pathology groups to account for cost, complexity, and current fee schedule and other payment source trends (e.g., CMS APC payment rates)
- Clinical consolidation relationship changes (32 consolidation pairs were added and 12 were deleted) to improve the efficiency of outpatient grouping based on observations in current outpatient claims data for claims with multiple significant procedures present
- Creation of nine New EAPG groups
- There were no EAPGs deleted for version 3.18
- Three EAPG groups had a type change, two of which were changed to incidental type (EAPGs 307 and 455)
- Nine EAPGs had a category change assignment and one EAPG had a category description change (Category 6)
- There were four EAPGs added to the standard packaging list and two EAPGs were removed
- Changes were made to service lines for several EAPGs, and two new service lines were added
- Preventive Diabetes: additional services flagged to identify as preventive services for diabetic patients

Additional clinical refinements were made to the following categories of EAPGs for improved clinical precision and to reflect currently observed outpatient claims reporting practices. The following list represents some of the more significant changes.

- Incidental Biological and Synthetic Application products: EAPG 455 and new EAPG 2010
- Allergy Tests: EAPGs 116 and new EAPG 2016
- Cardiac Electrophysiologic procedures: EAPGs 82 and 96
- Dental Procedures: EAPGs 350-366, 373-374, 379-382
- Home Health: new EAPGs 2009, 2050, 2051
- Patient Education and Ambulatory Monitoring: review of EAPGs 418 and 428

- Monthly Case and Treatment Management: new EAPGs 2070 and 2071 for monthly Case Management and Behavioral Health Case Management; new EAPG 2072 for monthly treatment management
- Unassigned HCPCS (EAPG 999) codes have been assigned to EAPG groups. Note that if EAPG 999 is returned under version 3.18, it is only associated with an error condition.

The net effect of these changes is a more clinically precise and accurate assignment of EAPG groups aligned with current clinical practice, costs, and trends. Details describing these clinical changes may be found in subsequent sections of this document.

EAPG changes

For EAPG 3.18 there are nine new EAPGs, there are no deleted EAPGs, and 26 revised EAPGs (descriptions, type, category, service lines). Note that any references to the outpatient claims data set in the details substantiating changes in assignment of codes or the development of new EAPGs is associated with the review of source claims from the previous CMS OPPS CY 2020 data set containing 90 million claims, and the new CMS CY2021 data set, which contains a total of 106 million claims. For additional details related to the claims data set and usage for creation of relative weights, please see the Relative Weights section of this document (page <u>39</u>).

Each year, the claims data set is reviewed to understand the relationship between major significant procedure visits and medical visits to the additional diagnostic, therapeutic or ancillary services reported with these events that may be supportive or adjunctive to the major events. As a result of that review, changes to EAPG types may occur. For version 3.18, there are three EAPGs having a type change, two of which are changing from type 5 (Incidental) to type 4 (Ancillary) and type 7 (DME) and one changing from type 2 (Significant) to type 25 (Diagnostic or Therapeutic procedure).

The complete list of EAPGs with type changes can be found on the tab labeled EAPG_LIST_TYPE_MOD in the attached Annual Summary of Changes spreadsheet (page <u>59</u>), and noted in the following table, which also includes observed frequency in the claims data set, and if the EAPG was added to the standard packaging list.
